OFFICIAL RULES FOR DYCD Rename YAIP/OSY/ISY Contest

By submitting an Entry, as defined below, to the **DYCD Rename YAIP/OSY/ISY Contest**, you are considered an Entrant, and you are agreeing to be bound by the following legal terms.

- 1. THE CONTEST:** The **DYCD Rename YAIP/OSY/ISY Contest** (the "Contest") will begin at 12:00:00 AM Eastern Standard Time ("EST") on January 17, 2017, and end at 11:59:59 PM EST on February 17, 2017. The Contest is sponsored by the City of New York, acting through its Department of Youth and Community Development (DYCD). Participation is subject to all federal, state and local laws and regulations. Void where prohibited or restricted by law. Entrant is responsible for checking applicable laws in their jurisdiction before participating in the Contest to make sure that their participation is legal, and to ensure that they comply with all relevant laws. Entrant is responsible for obtaining any permissions needed to use a prize.
- 2. ELIGIBILITY:** The Contest is open to residents of the City of New York, aged sixteen (16) or older at the time of entry. DYCD employees and their family members are not eligible to participate and receive prizes. The Contest is subject to all applicable United States federal, state and local laws and regulations. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and DYCD's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 3. HOW TO ENTER:** To enter, Entrant must include a signed Participant Agreement Form, with the necessary signatures ("Entry"). Entry may be emailed to YouthConnect@dycd.nyc.gov or mailed to Youth Connect, c/o the City of New York Department of Youth and Community Development, 123 William Street, 17th Floor, New York, NY 10038 beginning at 12:00:00 AM EST January 17, 2017, and ending at 11:59:59 PM EST on February 17, 2017. Mailed Entry must be postmarked by February 17, 2017. All Entrants must include their name, age, email address and phone number with Entry. Entrants may submit **ONLY ONE (1)** Entry to the Contest. If more than one (1) Entry is received, only the first Entry received will be considered.
- 4. SELECTION COMMITTEE:** DYCD will appoint a panel of judges consisting of representatives of the City of New York and select youth representatives. Personal identifying information for all Entries will be withheld from the panel of judges.
- 5. WINNER SELECTION:** ELIGIBILITY OF THE POTENTIAL WINNER IS SUBJECT TO VERIFICATION BY DYCD, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. One (1) winner for each program in the Contest will be announced on or about March 10, 2017. If the panel chooses an Entry that is, in DYCD's sole judgment, the same as, or substantially similar to, other Entries, the winning Entry will be chosen by a lottery of those Entries. The potential winner will be contacted via email, or phone if email cannot be reached, and asked to complete a Winner Acceptance Form. If a potential winner does not respond to DYCD's notice (either by email or phone call), or does not return the Winner Acceptance Form within 24 hours, that potential winner may be disqualified and the entry with the next highest number of judges' votes will be selected as a potential winner in its place. Return of any notification email as "undeliverable" or failure to fully comply with these Official Rules will result in disqualification. In the event of disqualification of any potential winner, the prize will be forfeited by that potential winner and the panel of judges will select a new potential winner from among the finalists. DYCD is not responsible for notifications that are misdirected, addresses or phone numbers that are no longer correct, or for any other reason beyond the control of DYCD that it is unable

to communicate with an Entrant who may be a potential winner. If such potential winner cannot be contacted within a reasonable time period, if the potential winner is ineligible, if any notification is returned undeliverable, or if the potential winner otherwise fails to fully comply with these Official Rules, DYCD may award the applicable prize to an alternate winner who had the highest score remaining of the eligible Entries. 6. **THE PRIZE:** The City will announce the winner(s) and award to the winner(s) a prize of an Apple iPad Air 2. If a selected winner is not eligible, in DYCD's sole judgment, the judging panel will select a new winner from among the finalist Entries. There will be no cash paid in lieu of prize. No substitution of prizes is permitted except by DYCD. The prize is not assignable or transferable. If a winner cannot participate for any reason, winner will forfeit the prize and DYCD, at its option and in its sole discretion, may select an alternate winner or the prize may not be awarded. All of the prize elements are subject to change and shall be determined by DYCD in its sole discretion. There is no approximate retail value of the prize. Any difference between stated value and actual value will not be awarded. Certain restrictions, as determined by DYCD, may apply. If a winner cannot comply with these restrictions or any other portion of these Official Rules, the prize will be forfeited in its entirety and an alternate winner will be chosen. All federal, state and local income taxes on prize and gratuities are solely the responsibility of the prize winner. Payments to potential prize winner(s) are subject to the express requirement that they submit to DYCD all documentation requested by DYCD in compliance with all applicable state, federal and local tax reporting and withholding guidelines. If a prize winner fails to provide such documentation or comply with such laws, the prize may be forfeited and DYCD may, in its sole discretion, select an alternative potential prize winner. DYCD will not have any responsibility with respect to maintenance of the Apple iPad Air 2 or any related merchandise awarded as a prize in this Contest.
7. **OWNERSHIP OF ENTRIES:** All Entries will become the sole and exclusive property of DYCD and DYCD will be the owner of all rights, titles and interests in the Entries and any and all related or derivative intellectual property. Entrant agrees that this consent is perpetual and cannot be revoked. Entrant agrees that nothing in these Rules grants them a right or license to use DYCD's name, trademark or service mark.
8. **WARRANTIES:** By submitting an Entry to the Contest, Entrant represents and warrants that their Entry: (1) is their own original work; (2) does not contain material that may be considered obscene, inappropriate for a general audience that may include minors, or defamatory; (3) does not violate or infringe upon the copyrights, trademarks, rights of privacy, publicity or other rights of any person or entity; (4) does not contain malicious code, such as viruses, timebombs, cancelbots, worms, Trojan horses or other potentially harmful programs or other material or information; (5) does not feature the name of a private individual without that individual's explicit written permission for its use; (6) does not and will not violate any applicable law, statute, ordinance, rule or regulation; and (7) does not trigger any reporting or royalty obligation to any third party. Entrant further represents and warrants that the rights that Entrant is granting under these Official Rules do not conflict in any way with any other agreement to which Entrant is a party, or with any commitments, restrictions, or obligations that Entrant is under to any other person or entity.

9. **ENTRY CONDITIONS AND RELEASE:** By submitting an Entry to the Contest, Entrant agrees to: (1) comply with and be bound by these Official Rules and the decisions of DYCD and/or the Contest judges which are binding and final in all matters relating to this Contest; (2) release and hold harmless the City of New York, DYCD, and Contest judges, and their respective parent, subsidiary, and affiliated companies, the prize suppliers and any other organizations or individuals responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the “Released Parties”) from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to an Entrant’s entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the publication, broadcast, transmission, performance, exploitation or use of entry; and (3) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys fees) arising out of or relating to Entrant’s participation in the Contest and/or Entrant’s acceptance, use or misuse of a prize.

DYCD reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, DYCD reserves the right to seek damages from any such person to the fullest extent permitted by law. DYCD’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
12. **LIMITATION OF LIABILITY:** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or receipt or use of any prize. If for any reason an Entrant’s submission is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, Entrant’s sole remedy is to provide another submission.
