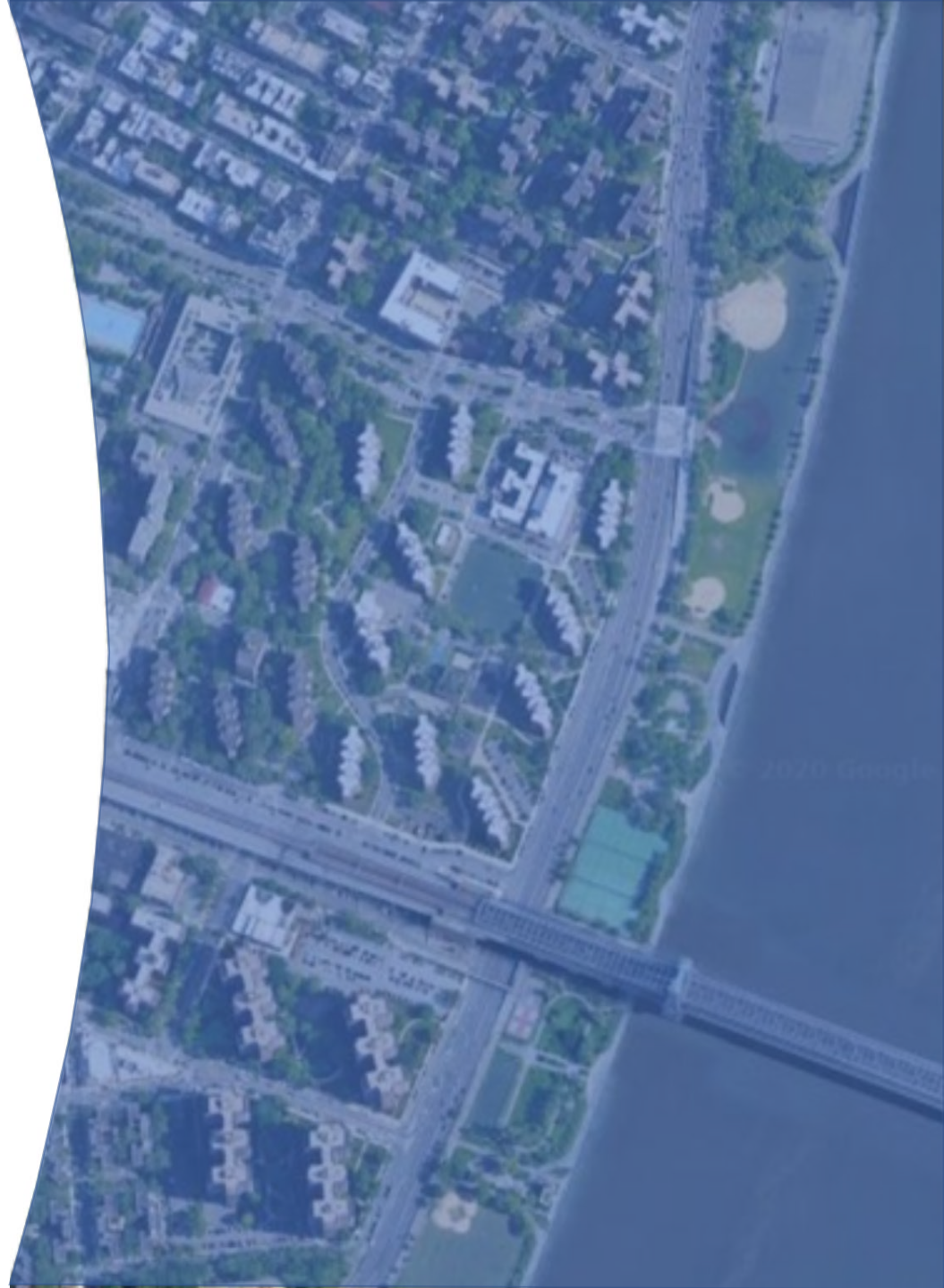

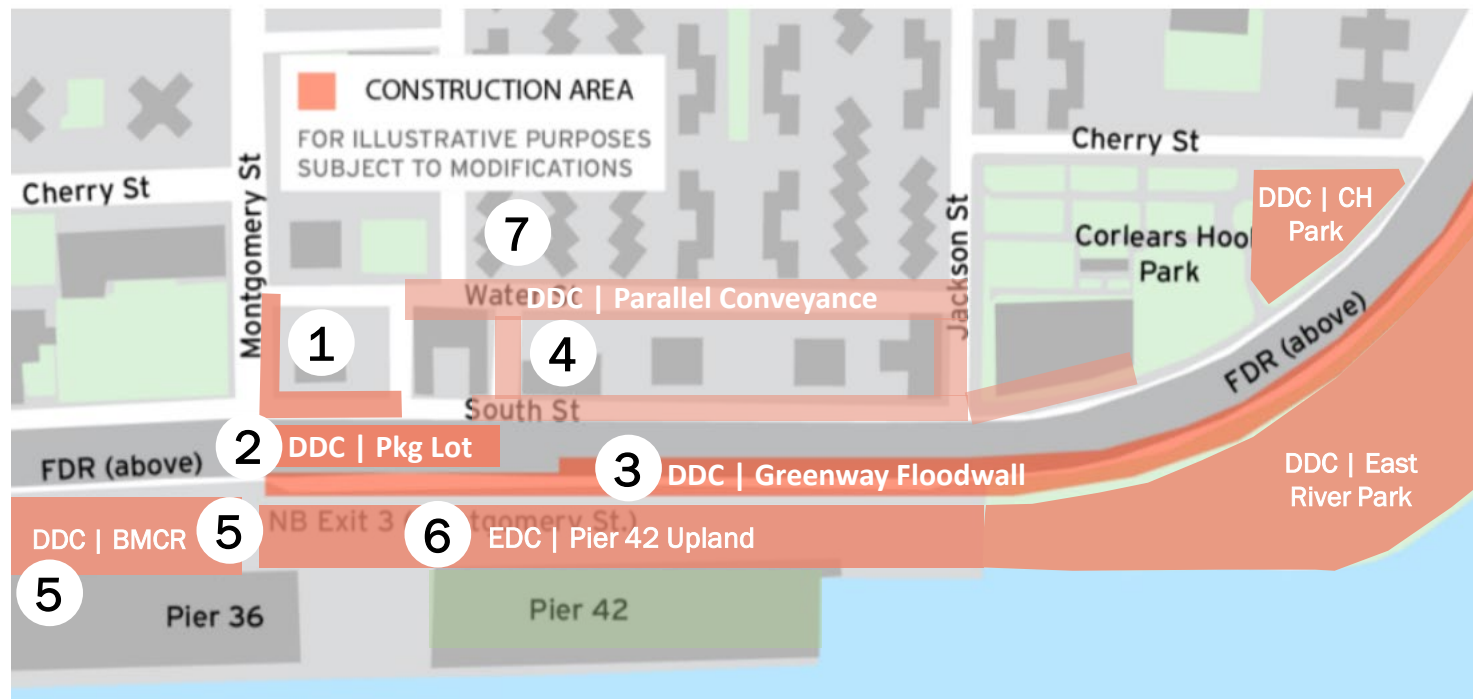

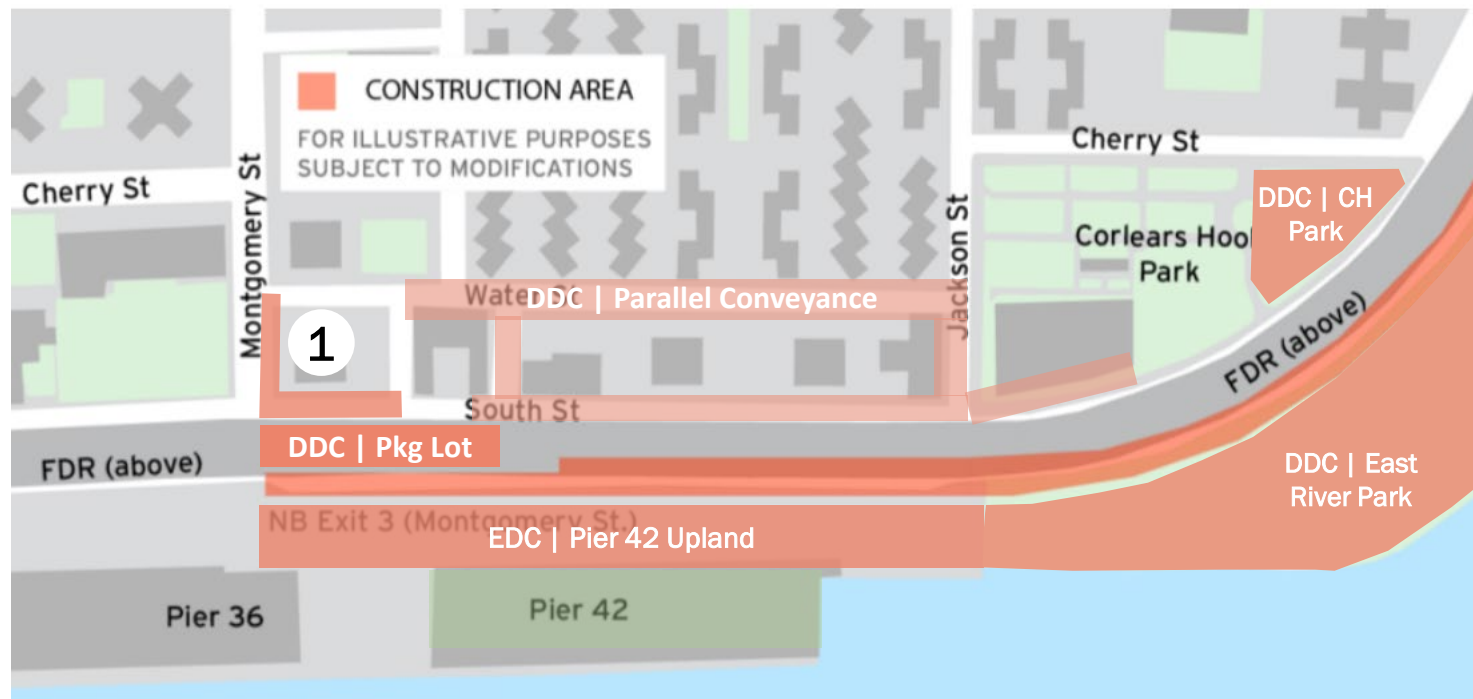
ACTIVITY AROUND GOUV GARDENS

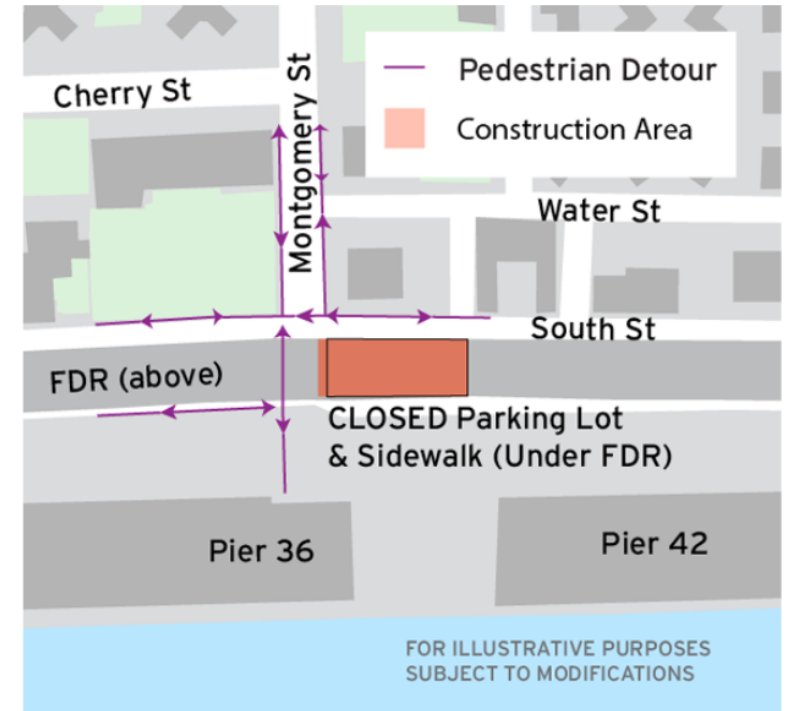
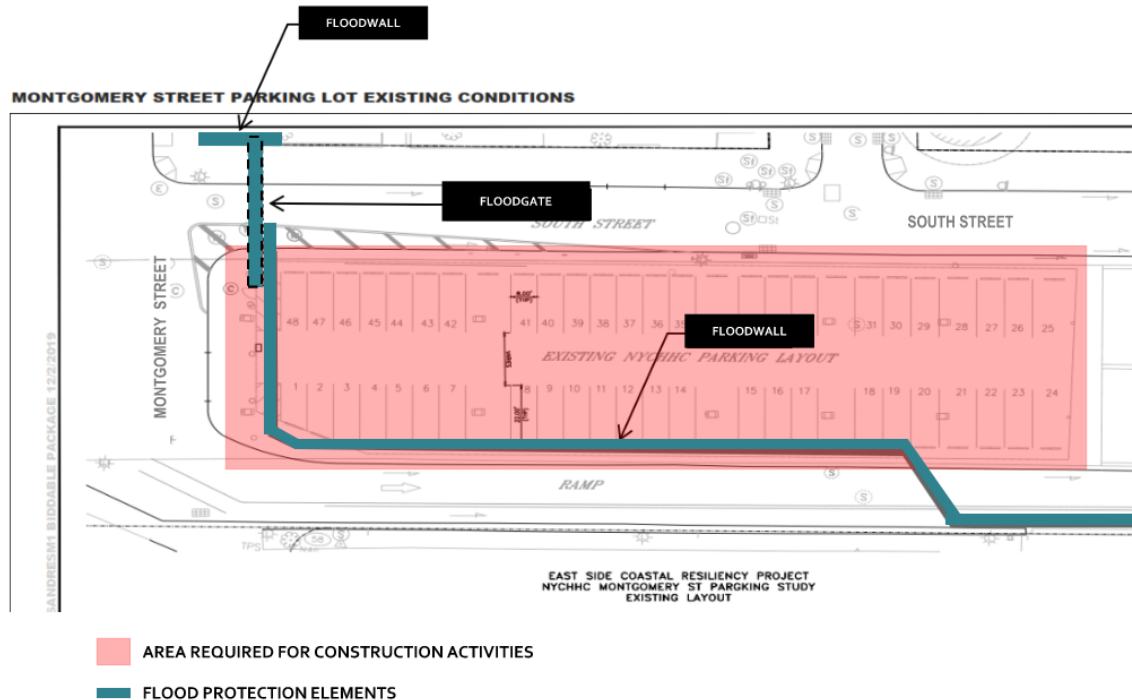
- ① DDC | ESCR PA1 Utility work near Montgomery St. & South St. to accommodate floodwall and floodgate construction

- a. Started February 2023 and will continue through fall of 2024
- b. Sidewalk closure in place
- c. Floodgate will connect with Gouverneur Gardens floodwall



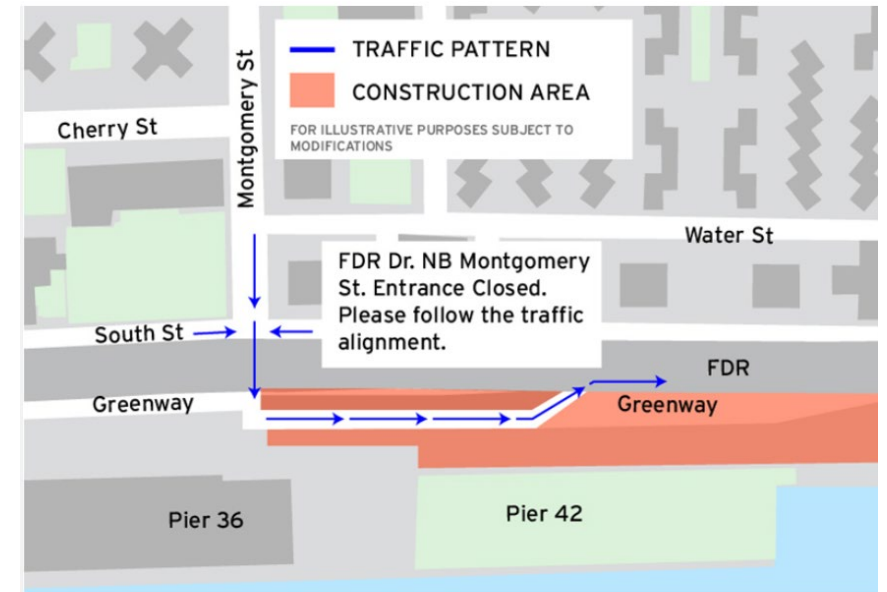
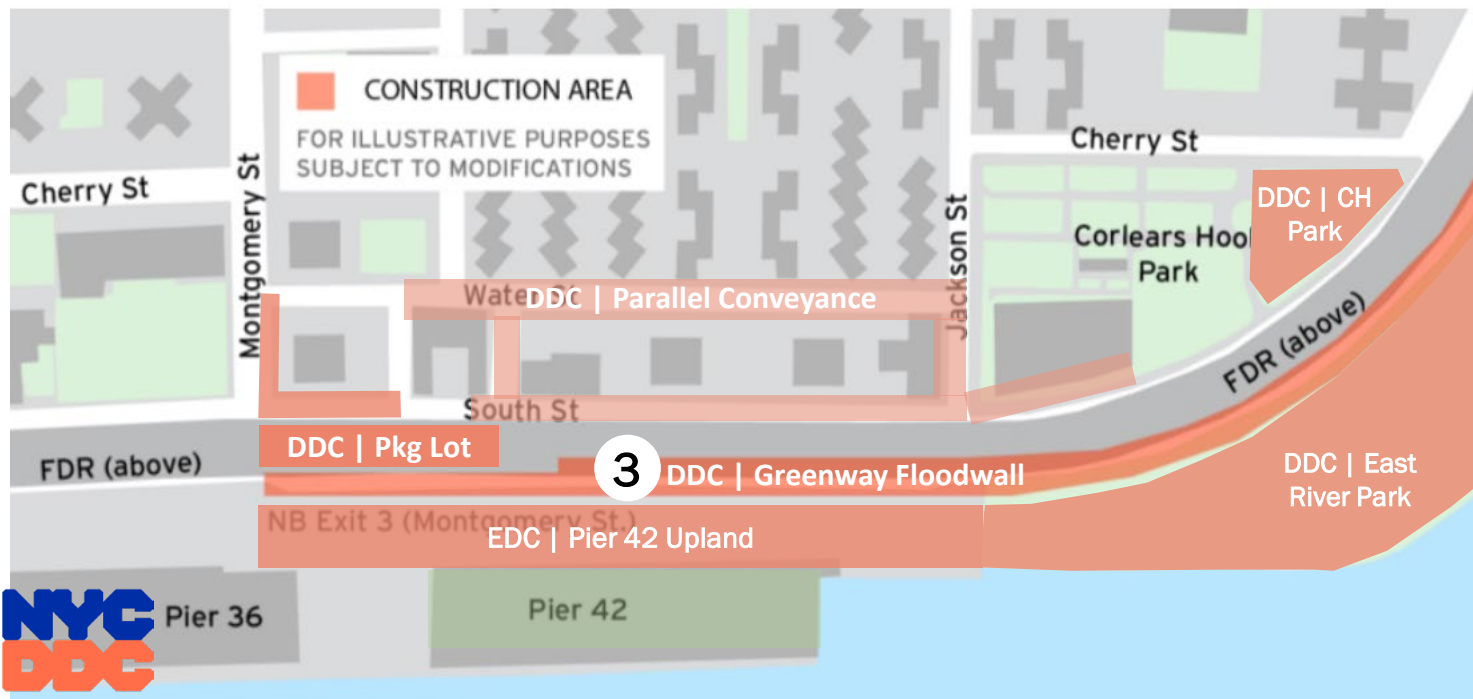
**SIDEWALK CLOSURE AT MONTGOMERY ST. UNDER FDR DRIVE
ONGOING UNTIL FURTHER NOTICE**

Construction activities will necessitate the closure of the sidewalk at Montgomery Street under FDR Drive (north side). This change will be in place 24 hours/day, 7 days/week. Traffic will be maintained and pedestrian detour is in effect. Please follow all signs and directions placed on-site to ensure safety.

ACTIVITY AROUND GOUV GARDENS

3 DDC | ESCR PA1 Greenway floodwall activities from Montgomery St. to Cherry St.

- a. work was originally scheduled as night work however the contractor has been able to perform most of this work during the day
- b. floodwall activities will continue through Spring 2024
- c. FDR on-ramp traffic shift starting September 15, 2023, to accommodate floodwall construction along FDR ramp



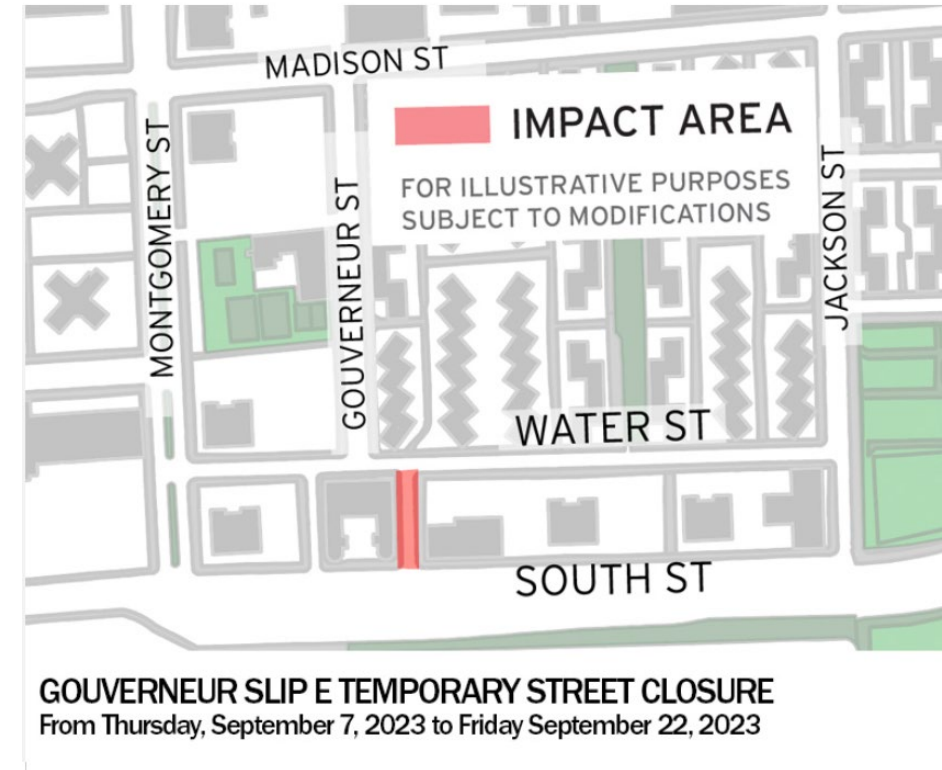
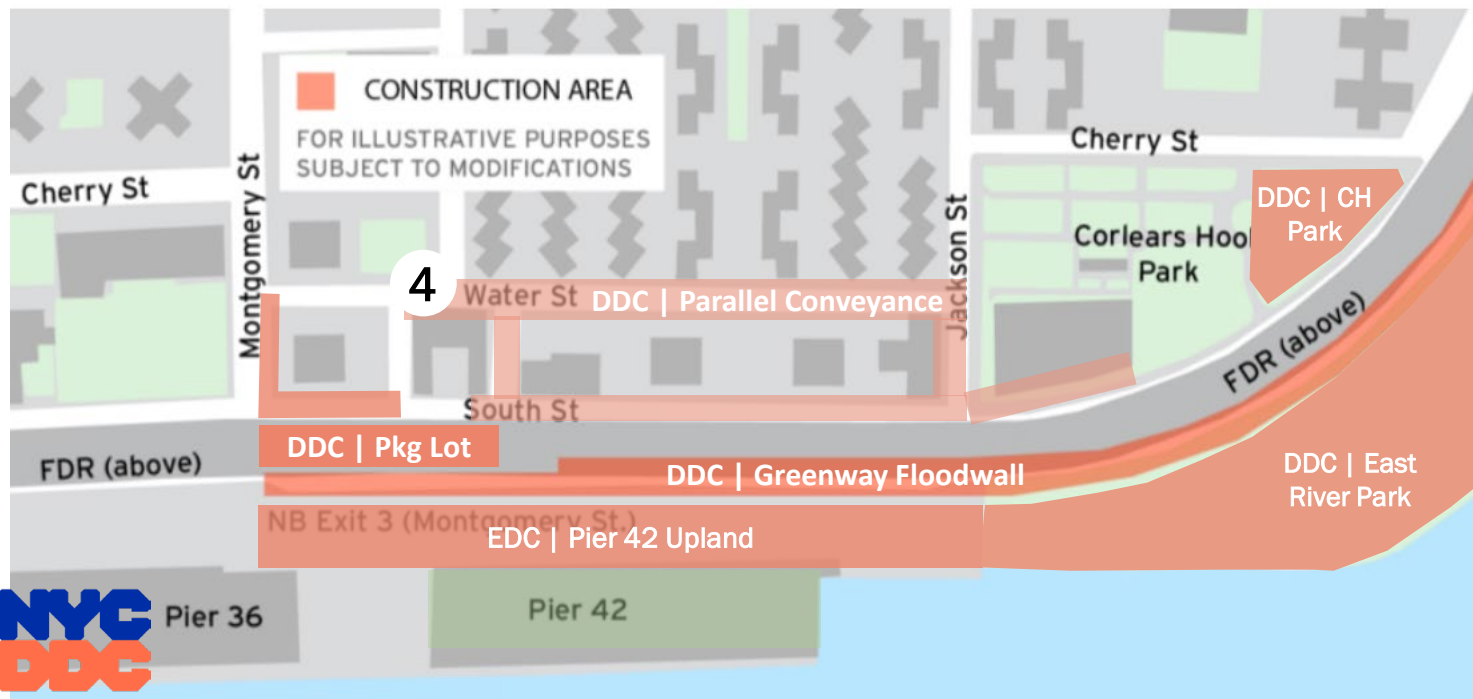
FDR DR. NB MONTGOMERY ST. ON-RAMP SHIFT STARTING FRIDAY, SEPTEMBER 15, 2023

Construction activities will necessitate the shift of the FDR Drive northbound Montgomery Street on-ramp onto the East River Park Greenway. Traffic on the FDR Drive will be maintained. Vehicles should follow all posted signs and striping.

ACTIVITY AROUND GOUV GARDENS

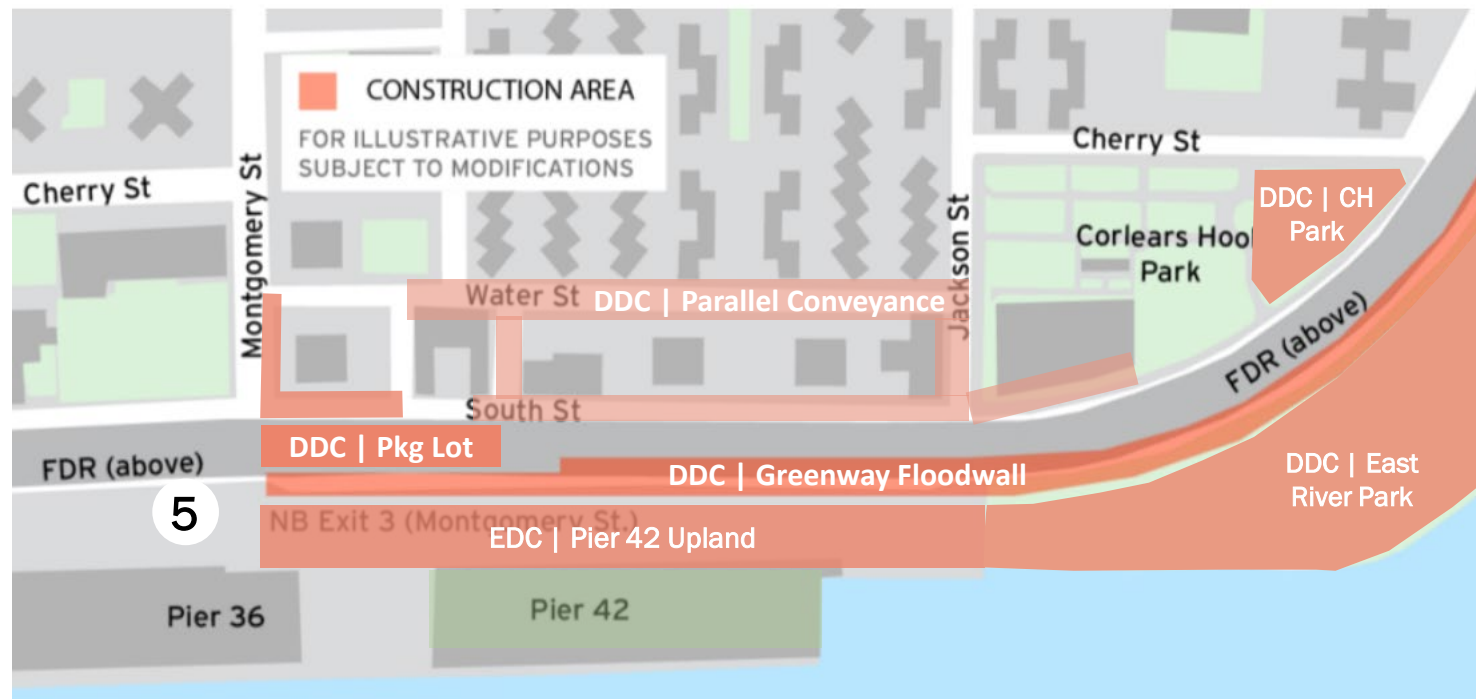
4 DDC | ESCR PC along Water Street, Jackson Street, Gouverneur Slip E., and South Street

- a. Water main upgrades and utility relocation
- b. Intermittent street closures on Gouverneur Slip E. **as required** to complete construction in different phases
- c. Parking Lot 5 Entrance moved to South Street during work hours (7:00am-4:30pm) during street closures
- d. Upcoming work: sewer upgrades



ACTIVITY AROUND GOUV GARDENS

- 5 DDC | BMCR construction activities
 - a. Construction fencing installed from Pier 35 to Brooklyn Bridge
 - b. Currently work is focused south of Pier 35, with some wall foundation work potentially progressing north beginning mid- to late- fall 2023
 - c. ConEd test pits at Montgomery Street being coordinated with other contracts (approx. 3-5 days)
