3	2/26/24-3/08/24	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Preparing for park reconstruction
4	2/26/24-3/08/24	7:00 am to 3:30 pm	Southbound shoulder between E 16 <sup>th</sup> Street and Murphy Brother	Floodwall construction continues.
5	2/26/24-3/08/24	7:00 am to 3:30 pm	Southbound shoulder between E 15 <sup>th</sup> Street and E 16 <sup>th</sup> Street	Floodwall construction continues.

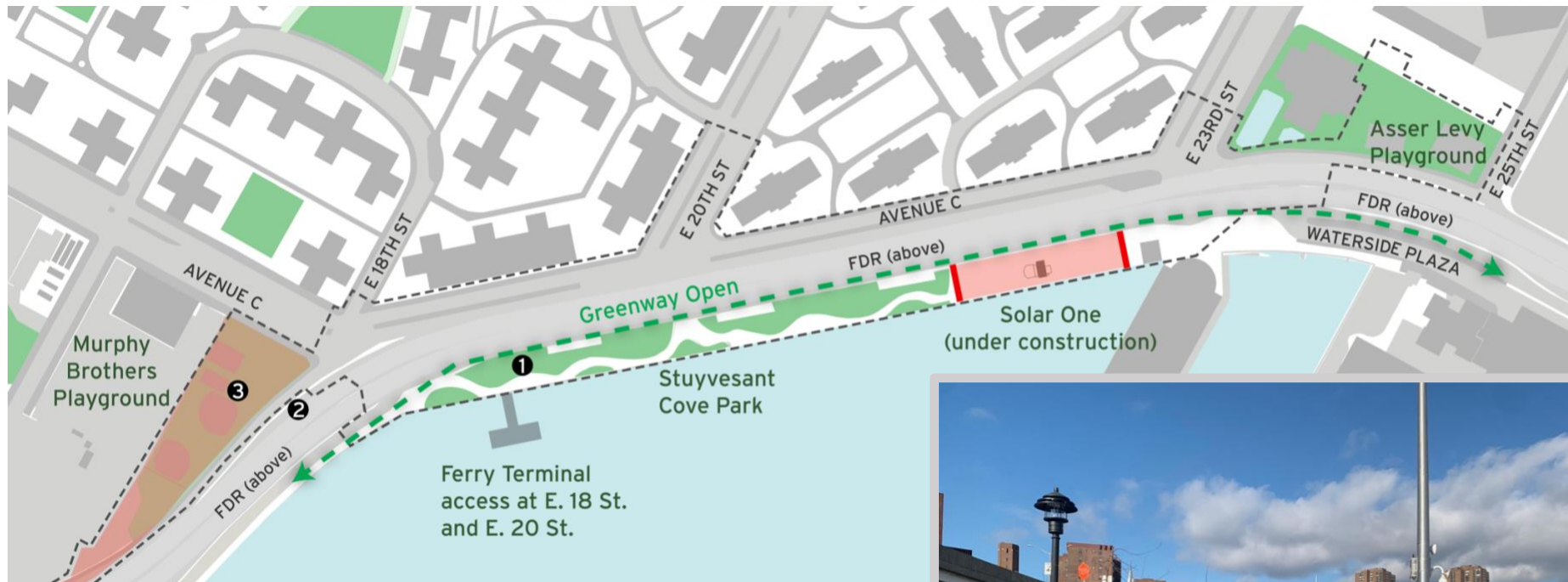

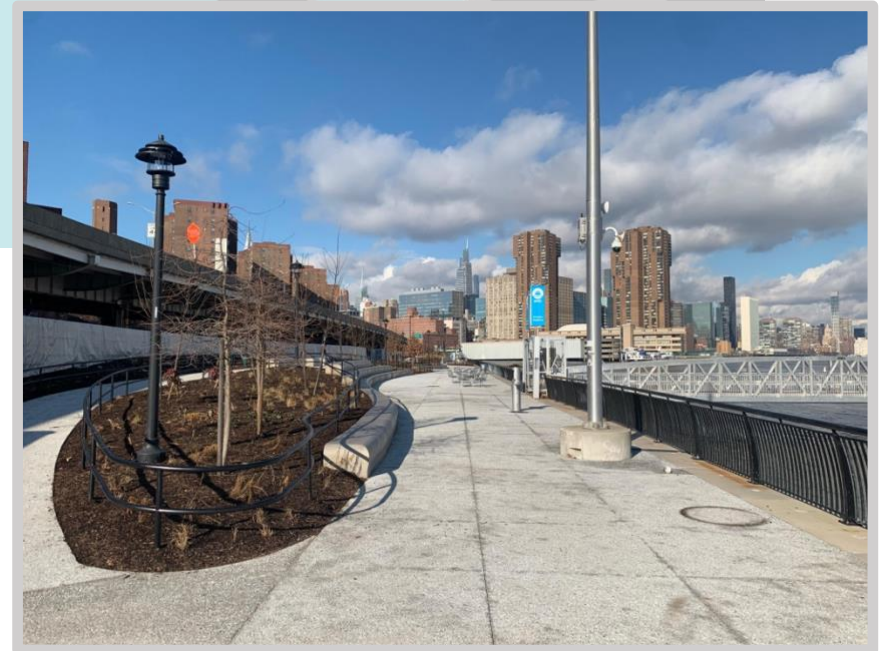
