Introduction

This guide is designed to assist you with completing your Not-for-Profit property tax exemption renewal forms.

In the following pages, we provide a step-by-step manual with detailed explanations to help you navigate the Department of Finance's online renewal system and submit your renewal forms with ease.

We also have a Frequently Asked Questions (FAQs) document, which you can find on our website at www.nyc.gov/notforprofit.

Helpful Hints for using the system

Required Fields

Throughout this system you will be asked to provide information and answer questions. There are certain fields that are required to be completed in order to move between screens or submit a renewal application.

If at any time you try to submit information by clicking Confirm or Submit Form and there is an error, you will see the message below. Fields that are blank or filled-in incorrectly will be highlighted in red like this:

- Some fields are not completed or require data in a specific form or require a minimum / maximum number of characters. Please fill or correct the corresponding fields indicated on the form.

Once you have made the necessary corrections, you will be able to submit and move to the next section.

Text boxes

A text box will appear if you answer YES to a question. Text boxes require 25 characters. You may have to expand on your answer if you get an error message.

Time out

Like many online applications, if you have no activity for one hour, you will lose all of your information, so be sure to submit or save your form if you plan to be away from your computer.

Navigating the website


The orange bar below allows you to:

- Jump to the Property List to see the BBLs that require not-for-profit renewals
- Jump to Owner Information so you can see what information you confirmed for the organization's owner and contact information
- Jump to Contact Us if you have questions
- Click Log off when you are ready to exit the application. All of your saved work can be completed or accessed when you log in again

Log in – Screen 1

On the Welcome page, you will be asked to enter your User ID and password to log in. The User ID and password can be found on the letter you received in October. User IDs and passwords are case-sensitive, so enter them exactly as they appear.

Helpful hint: Be sure not to mistake “0” for “O” or “1” for “l”.



If this is your first time logging in, you will see **Owner Information – Screen 2**. If you have logged in before, your next screen is **Property List – Screen 3**, go to page 9.

If you filed your renewal form online last year and you forgot your password, you may click **Forgot your password?** The password will be sent to the email address you submitted last year. If you did not submit online last year, you will have to use the password from the letter sent in October.

Change Password

Click **Change Password** in the orange bar.



You will be asked to enter the password we sent, then type and confirm the new password that you want.

Change Your Password

Select a password with at least 6 characters, including at least one letter or one number.

Change Your Password

It is optional to change your password. Please remember that passwords are case sensitive if you decide to use upper and lower case letters. In the box to the left, enter the password we sent, then enter the new password, and then re-type the new password. Click "Change Password" to make the change, or "Cancel" to keep the original. If you change the password, you will receive a confirmation message via email.

Helpful hint: The password must have 6 characters including one letter or number.

Click **Change Password** to keep the one you have entered. Click **Cancel** to keep the current password.

If your changed password is successful, you will see a screen like this:

Profile Information – Screen 2

This screen will only appear the first time you log into the Commercial Exemptions and Abatements Online Renewal system. If you filed online last year, you will go right to the Property List. See page 9.

The only field you cannot modify is the 'Name' field within the **Owner Information** section. If the name displayed in this box is incorrect, please contact us at <http://www.nyc.gov/contactnonprofit>. We verify that the property has not been sold to a new owner. If the property has been sold and the new owner is an NFP (Not-for-Profit), that organization has to submit a new application for exemption.

Property List – Screen 3

This screen lists each property owned by your Not-for-Profit that receives a not-for-profit property tax exemption. All properties that receive a full or partial not-for-profit property tax exemption are required to complete a renewal form. If you have signed-on previously, you will arrive here after entering the User ID and password.

Atop the property list you will see **Number of Properties: X**. This number is the total number of Borough-Block-Lots (BBLs) owned by your organization that have a full or partial Not-for-Profit property tax exemption.

Understanding the Property List:

Each row in the list represents the property address (where the property is located), the BBL, Status and Type of Form.

Forms describes the type of renewal form required for the BBL. There are three (3) different types of renewal forms:

1. General – organizations that are schools, hospitals, houses of worship, charities, veteran’s organizations or cultural organizations would complete this form.
2. Parsonage – this form is for properties owned by a house of worship to house the officiating clergy.
3. Contemplated Use – if the Not-for-Profit is renovating/building on the property, and the property is not being used, this is the required form.

Status describes the status of the renewal form. A renewal form can be in one (1) of three (3) different statuses:

1. Not-Started – you have not clicked the link to open the form.
2. In Progress – you have started to complete the form, but were not able to finish. Your work has been saved.
3. Completed – you have opened, completed and submitted the form. A confirmation email has been sent to the email address you provided to acknowledge that the form has been submitted.


Search and Show Status

Above the properties table you will see a 'Search' field and a 'Show Status' list.



Search - You use this function to search by address. You can find a specific property or properties located on the same street/avenue. For example, if you own multiple properties that have an address on "Jamaica Avenue", you may enter "Jamaica Avenue", "jamaica ave" or "jamaica" in the search box. If you search on "Avenue" or "ave" or "avenue", only those addresses with avenue will appear. To get the entire list back, click your browser's back arrow.

Show Status – the Property List is defaulted to show all forms Completed, In-Progress, and Not-Started. To display only one status, click the down arrow and all options appear.



Click the status you want to display. Only the BBLs with that form status appear. If there are no BBLs matching that form status, you will see:

Owner's Name and **Mailing Address** were confirmed when you first logged-in to the application.

Property Address and **Borough-Block-Lot** are identifiers for this property. Note: vacant land or lots that do not have a building may not have a building number, but just a street name in the address box.

Building Class is a descriptive code Finance uses to identify characteristics of the BBL. It may describe construction material, type of use, or number of units (residential or commercial). To see a list of building class codes, visit <http://nycprop.nyc.gov/nycproperty/help/hlpblgdcode.html>. Alternatively, if you view a BBL's Account History on www.nyc.gov/finance you will see the BBL's building class and from there you can link to the list of building class codes.

Tax Class is a legal categorization determined by property type. There are four tax classes:
TC 1 – One to three-unit residential properties
TC 2 – Residential property with more than 3 units including cooperatives and condominiums
TC 3 – Utility company equipment and special franchise property
TC 4 – All other real property, including office buildings, factories, stores, hotels and lofts





There are 6 questions to answer about ownership and use of the property. Contemplated Use exemptions are granted when a Not-for-Profit organization is planning, renovating, or constructing a new building on their BBL. Questions 2e and 2f are your opportunity to tell Finance where you are with the progress toward completion of the exempt use of this BBL. If you answer NO to all the questions in Section Two, proceed to Section Three, go to page 22.

Question 2f – If there has been no alteration/construction work on the BBL, but you have applied to the Department of Buildings for a work permit, indicate YES. A calendar will appear. Scroll to the appropriate month, and highlight the date. The month, day and year will appear in the box.
