ADDENDUM #3

The Department of Housing Preservation and Development is issuing **Addendum #3** to the Request for Qualifications for Qualified Marketing Agents ("RFQ" hereafter).

I. QUESTIONS AND ANSWERS

a. RFQ Questions by email

The following Questions were presented to HPD via email between 10/22/2020 and 1/5/2021. The Answers to those Questions are provided below for clarification and information purposes only, and do not change the terms and conditions as contained in the issued RFQ:

<u>Question #1</u>: We are interested in submitting our RFQ to qualify as a marketing agent. We have experience in property management and in-house leasing. We are in the process of getting LIHTC and Fair Housing Certification. My question is if we need to be a licensed real estate broker in order to qualify as a Marketing Agent.

<u>Answer #1</u>: For all qualification considerations for this RFQ, please see Section III. ("Qualification Considerations", page 6) of the RFQ. Licensure as a real estate broker is not a requirement.

<u>Question #2</u>: For the use of, the owner's reference, as well as for the preparation of the entity's Income Tax Return, our company utilizes internally prepared financial statements. Kindly advise if such statement sufficiently satisfies the Marketing RFQ Financial Statement requirement.

Answer #2: Please see Section IV.A.7. ("Financial Statements", page 8) of the RFQ.

Question #3: What's the yearly compensation for this role?

<u>Answer #3</u>: Please see Section I ("Introduction", page 2) and Section V ("Conditions", page 10) of the RFQ for information about the role of Marketing Agents. HPD and HDC do not compensate Marketing Agents; compensation is by Developers/Owners.

Question #4: Pre-Covid, pre-submission attendees/registered parties for this type of RFQ would be made available. Typically, this would provide an opportunity for firms to potentially joint venture with others. In addition, a firm may be seeking a partner or experienced marketing agent as a staffer to support their proposal. Please advise if a list of pre-submission conference attendees or registered parties can be made available.
