

## MICE, COCKROACHES, AND RATS AFFIDAVIT OF COMPLIANCE (AF-6) VIOLATIONS ISSUED AFTER JANUARY 19<sup>TH</sup>, 2019

Property owners must submit this affidavit (AF-6) with the documentation required by the Certification of Correction for mice, cockroaches, or rat's infestation for violations issued **after January 19<sup>th</sup>**, **2019 and overdue (not timely or validly certified)** in order for HPD to dismiss the violation.

Overdue MICE, COCKROACHES, AND RATS VIOLATIONS on record that were not properly certified can be dismissed **ONLY IF**:

- A. **HPD** has inspected and found the work properly completed. You can check HPD's website at <a href="https://www.nyc.gov/hpd">www.nyc.gov/hpd</a> and use HPDONLINE from the home page to determine if HPD has already inspected. The violation will be in DEFECT status.
  - If the violation has <u>not</u> already been observed corrected by HPD, a properly completed Dismissal Request form with the appropriate fee must also be submitted to HPD. You can obtain a Dismissal Request form at <u>www.nyc.gov/hpd</u>.

B. If you qualify for a Post-Dismissal Request Inspection, Self-Certification (CV-1) process. Submit this affidavit (AF-6) with the documentation along with the CV-1 form. All submissions of the CV-1 must be completed within 45 days of the final date of Dismissal Request Inspection.

C. The appropriate integrated pest management and work practices required by Administrative Code §27-2017.8 and 28 RCNY §54-04(a) were used to correct the condition. A detailed description of the integrated pest management and work practices for violations issued after January 19<sup>th</sup>, 2019 is enclosed.

## To properly complete this affidavit:

- The validly registered owner or agent must complete the affidavit (See <a href="www.nyc.gov/hpd">www.nyc.gov/hpd</a> for information about property registration) once the required work is completed properly and in the affidavit in front of a notary public, (who must also sign and affix his or her stamp on the form). On the affidavit, the property owner or agent must indicate one or multiple violation sequence numbers for violations corrected at the same time within single apartment.
- Submit the Affidavit of Compliance to HPD at the appropriate borough office listed below for the borough of the building. As noted above, if the violation has not already been inspected (and is in defect status because the condition was observed to have been corrected), the Dismissal Request form (with the appropriate fee) must also be submitted, requesting a reinspection of the violations indicated on the affidavit.
