

**Amendment #2 to  
Data Transfer Agreement  
Between  
The City University of New York (CUNY)  
and**

**The New York City Department of Social Services Human Resources Administration (HRA)**

WHEREAS, CUNY and HRA (the "Parties") executed a Data Transfer Agreement (the "Agreement") on August 27, 2019 to enable CUNY to transfer certain Data, as defined in the Agreement, to HRA for purposes of the Fair Fares Program;


WHEREAS, Paragraph 10(b) of the Agreement requires that any modifications to the terms and conditions of the Agreement must be made in writing and signed by an authorized representative of each party; and

WHEREAS, the Parties amended the Agreement by Amendment #1, dated October 4, 2019 to allow CUNY to send a fourth round of texts to potentially eligible students, and now wish to further amend the Agreement by this Amendment #2 to send a fifth round of texts;


NOW THEREFORE, in consideration of the mutual covenants and agreements herein made, the Parties agree to the following:


1. Paragraph 6(a) of the Agreement will be amended by changing the word "four" in the second sentence to the word "five," so that the new sentence will read "HRA agrees to purchase 300,000 texts from Mozeo, at an amount not to exceed six thousand dollars (\$6,000), to enable CUNY to send five rounds of texts to approximately 75,000 students."
2. In all other respects, the original Agreement remains in full force and effect.
