

MODIFICATION AGREEMENT BETWEEN THE NEW YORK CITY HUMAN
RESOURCES ADMINISTRATION AND DEPARTMENT OF PARKS AND RECREATION

This MODIFICATION AGREEMENT is dated August 18, 2014,
and is between the New York City Human Resources Administration ("HRA"), with offices at
180 Water Street, New York, New York 10038 and the New York City Department of Parks and
Recreation ("DPR"), with offices at 830 Fifth Avenue, New York, New York 10065
(collectively, the "Parties").

WITNESSETH:

WHEREAS, the Parties entered into a Memorandum of Understanding ("MOU") to
provide low-income job seekers with increased access to viable job opportunities in the five
boroughs and surrounding suburbs; and

WHEREAS, the term of the MOU is from July 1, 2012 through April 30, 2014; and

WHEREAS, funding for the program has not been exhausted; and

WHEREAS, the Parties now wish to modify the term of the MOU, so that DPR can
continue to draw down remaining funds.

NOW THEREFORE, the Parties agree as follows:

ARTICLE 1. EFFECT OF CHANGES ON THE AGREEMENT

Except as modified herein, all of the terms, covenants, and conditions of the Agreement shall
remain unchanged and in full force and effect.

ARTICLE 2. MODIFICATION TO THE TERM OF THE MOU


Paragraph 1 of the MOU is hereby deleted in its entirety and replaced with the following:

*"This MOU will be in effect from July 1, 2012 through October 31, 2014, with an automatic
renewal for one (1) additional twelve (12) month term, subject to the appropriation and
availability of funds."*


