

THIS SECOND MODIFICATION AGREEMENT ("Second Modification Agreement") dated this 9th day of February, 2014, between the City of New York acting through the Department of Social Services of the Human Resources Administration ("Department" or "HRA") 180 Water Street, New York, New York 10038 and New York City Department of Sanitation ("DSNY"), with offices at 137 Centre Street, New York, NY 10013 (collectively, the "Parties").

WITNESSETH:

WHEREAS, the Parties hereto entered into an agreement (the "Agreement") for DSNY to employ and administer a Work Experience Program ("Program") for 1,000 public assistance recipients, for a one (1) year period from July 1, 2011, through June 30, 2012 with three (3) automatic one (1) year renewal periods; and

WHEREAS, the Parties hereto entered into a modification agreement ("First Modification Agreement) effective as of October 1, 2012, in order to increase the amount of public assistance recipients receiving services under the Program from 1,000 to 1,500 and to adjust the reimbursement to DSNY accordingly; and

WHEREAS, the Department seeks hereby to modify the services by modifying the Agreement and budget pursuant to Sections 4-02(b)(1)(ii), 4-02(b)(1)(vii), and 4-02(b)(2) of the Procurement Policy Board Rules ("PPB Rules"); and

WHEREAS, DSNY, who has performed satisfactorily, is ready, willing, and able to provide such services in accordance with the mutual covenants, terms and conditions contained herein;

NOW, THEREFORE, in consideration of the mutual covenants herein contained, the parties hereto have agreed and do hereby agree as follows:

1. Except as modified herein or modified previously, all of the covenants, terms and conditions of the Agreement shall remain unchanged, and are hereby ratified and confirmed as in full force and effect.
2. The terms of this Amendment are retroactive to and effective as of July 1, 2013.

3. MODIFICATION OF SCOPE OF RESPONSIBILITIES: DSNY

- A. Article II, Paragraph 1, as modified by the First Modification Agreement, is hereby deleted in its entirety and replaced with the following:

“DSNY Agrees to employ and maintain the capacity to administer a Work Experience Program for a minimum of 1,500 Cash Assistance recipients throughout the year in Maintenance Services and Office Services work assignments.”

4. MODIFICATION OF THE BUDGET AND “NOT TO EXCEED” AMOUNT

The Department hereby modifies the Agreement by increasing the “not-to-exceed” amount by \$28,750.00 from the original amount not-to exceed \$448,150.00 to a new amount not-to-exceed \$476,900.00 pursuant to the budget annexed hereto as Exhibit 1 and incorporated by reference. The rates stated in the Agreement or amendments thereto shall remain unchanged by this Modification except as noted herein. The budget contained in Exhibit 1 as found in the First Modification Agreement is hereby replaced with the new budget contained in Exhibit 1 of this Second Modification Agreement.

5. PROCUREMENT POLICY BOARD RULES

This Modification Agreement is subject to the Rules of the Procurement Policy Board of the City of New York (“PPB Rules”). In the event of a conflict between the said Rules and a provision of the Modification Agreement, the Rules shall take precedence.
