

THIRD RENEWAL OF COOPERATIVE AGREEMENT BETWEEN
THE NEW YORK CITY HUMAN RESOURCES ADMINISTRATION AND
THE CITY UNIVERSITY OF NEW YORK

THIS is the THIRD RENEWAL ("Third Renewal"), of that November 21, 2011, Cooperative Agreement for the Information Technology Specialist Fellowship Agreement ("Agreement") between the New York City Human Resources Administration ("the Department" or "HRA"), with offices located at 180 Water Street, New York, New York 10038, and the City University of New York ("CUNY"), with offices located at 205 East 42nd Street, 9th Floor, New York, N.Y. 100175 (collectively "the Parties"). The Effective Date of this Third Renewal is July 1, 2014 and its end date, June 30, 2015.

WITNESSETH:

WHEREAS, the parties entered into an Agreement for the period November 21, 2011 through June 30, 2012, whereby CUNY would provide fellowships for some IT Specialists to work at HRA at the conclusion of an IT Internship with HRA; and

WHEREAS, in Article 1, Section 1.2, the Agreement authorizes the Parties to renew it for four (4) additional one year terms, this Third Renewal being the third of these renewals; and

WHEREAS, in Article 17, the Agreement authorizes the Parties to amend it in writing; and

WHEREAS, in this Third Renewal the Parties wish to amend several sections, listed below;

NOW, THEREFORE, the Parties agree as set forth above and below:

- 1) Pursuant to the terms of the Agreement, the Parties exercise their right and option to renew the Agreement and hereby renew the Agreement for the period from July 1, 2014 through June 30, 2015, unless sooner terminated pursuant to the terms of the Agreement.
- 2) The compensation rates specified in Article 6 are hereby deleted in their entirety and replaced by the rates specified as "Compensation Rates" in Exhibit 1.D.
- 3) Agreement Exhibit 1.C, 2013-2014 Budget, is replaced by Exhibit 1.D, for the 2014-2015 Budget Term.
- 4) The total amount not to exceed pursuant to this Third Renewal shall be \$700,000. It is agreed that HRA will provide an initial amount of \$525,000

in accordance with the Budget attached herein as Exhibit 1.D. Additional funding up to the total amount not to exceed \$700,000 will be provided as needed. CUNY must notify HRA in writing when funding in excess of the initial \$525,000 is needed. In no event shall the total amount under this Third Renewal exceed \$700,000.

- 5) Article 7.2 of the Agreement is hereby amended to the extent that all invoices shall be submitted to Ahmad Naseer, Deputy Director of Budget and Contracts, 15 Metrotech Center, 12th floor, Brooklyn, N.Y. 11201. All other terms and conditions of this Article remain the same.
- 6) Article 9 of the Agreement is hereby amended to the extent that all notices required by the Agreement shall be delivered by hand or trackable overnight delivery services as follows:






