

**INTRA-CITY MODIFICATION AGREEMENT  
BETWEEN HRA, CEO AND DOE REGARDING THE  
EVALUATION AND MONITORING OF THE UNIVERSAL PRE-KINDERGARTEN  
PROGRAM**

This **MODIFICATION AGREEMENT** (“Modification Agreement”) effective as of October 15, 2015, is between the New York City Department of Education (“DOE”), with offices at Tweed Courthouses, 52 Chambers Street, New York, NY 10007, the City of New York Human Resources Administration (“HRA”), with offices at 150 Greenwich Street, New York, New York and the City of New York Center for Economic Opportunity (“CEO”) Office of The Mayor, City of New York , 253 Broadway, New York, NY 10007 (together, the “Parties”, one being a “Party”).

**WITNESSETH:**

**WHEREAS**, on April 3, 2012, HRA and CEO entered into an agreement with the research and evaluation firm Westat to provide government research and evaluation services to the City’s Poverty-reducing Initiatives; and

**WHEREAS**, CEO and DOE have chosen Westat to conduct two interrelated studies that together form a systemic approach to the evaluation of the implementation and outcomes of New York City’s expansion of the Universal Pre-Kindergarten (“UPK”) (the “Westat Agreement”);

**WHEREAS**, the Parties entered into an Intra-City Agreement (“Agreement”) dated August 1, 2014 pursuant to which DOE provided funding to HRA who in turn provided the DOE with monitoring and evaluation services (“Phase 1, 2, and 3 Services”) in accordance with the Westat Agreement; and

**WHEREAS**, Phase 1 and 2 Services are complete and the Parties wish to provide further funding for Phase 3 Services; and

**WHEREAS**, the Parties wish to extend the Term of the Agreement to the anticipated completion date of Phase 3 Services; and

**NOW THEREFORE**, in consideration of the mutual covenants herein contained, the Parties have agreed and do hereby agree as follows:

1. Except as modified herein, all of the terms, covenants, and conditions of the Agreement shall remain unchanged and in full force and effect.
2. The “not-to-exceed amount of the Agreement is hereby increased by one million nine hundred four thousand eight hundred seventy seven dollars (\$1,904,877) from one million nine hundred ninety nine thousand eight hundred eighty four dollars (\$1,999,884) to three million nine hundred four thousand seven hundred sixty one dollars (\$3,904,761) pursuant to **Exhibit A**, the Budget which is annexed hereto and incorporated herein.

3. The Term of the Agreement is hereby extended to December 31, 2016, the anticipated completion date of Phase 3.
