FIRST RENEWAL OF MEMORANDUM OF UNDERSTANDING BETWEEN THE NEW YORK CITY HUMAN RESOURCES ADMINISTRATION AND THE NEW YORK CITY DEPARTMENT OF HOMELESS SERVICES

THIS FIRST RENEWAL AGREEMENT ("First Renewal") dated \_\_\_\_\_\_\_\_, 201 between the City of New York acting through the Human Resources Administration ("HRA"), with offices located at 150 Greenwich Street, New York, New York 10007 and the New York City Department of Homeless Services ("DHS" or "Contractor"), with offices at 33 Beaver Street, New York, New York 10004 (hereinafter "the Parties").

## WITNESSETH:

WHEREAS, the Parties entered into a Memorandum of Understanding ("the MOU") whereby DHS allowed authorized employees of HRA's New York City Municipal Identification Card ("IDNYC") Program access to DHS client information for purposes of verifying information provided by IDNYC applicants; and

WHEREAS, the term of the MOU was one year from the effective date of January 18, 2017, with the option to renew for three (3) additional, one (1) year terms upon mutual written agreement; and

WHEREAS, the Parties now wish to exercise their first option to renew the MOU under the same terms and conditions except as modified herein;

NOW, THEREFORE, the Parties have agreed and do agree as follows:

- Pursuant to Article 1 (B) of the MOU, the Parties exercise their right and option to renew the MOU and hereby renew the MOU for the period from January 18, 2018, until January 17, 2019, unless sooner terminated pursuant to the terms of the MOU.
- 2. For purposes of this First Renewal, Attachment A of the MOU is hereby deleted in its entirety and is replaced with the Attachment A attached hereto and incorporated by reference.
- 3. Except as expressly amended by this First Renewal, the terms and conditions of the MOU and any modifications and Renewals thereto remain unchanged and in full force and effect.
