## **COMMISSION FINDINGS**

The Commission NOTED that the building's style, scale, materials, and details are among the features that contribute to the special architectural and historic character of the West Chelsea Historic District

Pursuant to Section 25-307 of the Administrative Code of the City of New York, the Commission APPROVED THE PROPOSAL WITH MODIFICATIONS, finding:

- -that the work will not damage or obscure any significant features;
- -that the existing and proposed signage, consisting of marquee signs, poster and menu boxes, and painted signs, will recall the variety of signage found historically at this building and buildings of this age and type, and will facilitate the adaptive reuse of this historic garage building;
- -that the modification of the existing marquee will help conceal framing and wiring, resulting in a less cluttered appearance;
- -that the proposed marquee will be modest in size, will match the existing marquee at the building in terms of materials, details, and dimensions, and will reinforce the symmetry of the façade;
- -that the proposed LCD signage is modest in size and will feature rotating static images which will be in keeping with the existing poster signage at the building and with signage typically found at theater buildings;
- -that the proposed signage will be installed at mortar joints to the greatest extent feasible;
- -that the painted signage at the modern doors will be modest in size and will facilitate wayfinding;
- -and that the overall amount of signage will not be excessive or detract from the significant architectural features of the building or streetscape.

However, in voting to grant this approval, the Commission REQUIRED:

- -that the "A" and "B" letters at the top of the gables be eliminated;
- -and that the "Chelsea Factory" signs at the larger arched openings be painted instead of pin-mounted.
