




EXISTING FRONT ELEVATION & AREAWAY SECTION




PROPOSED FRONT ELEVATION & AREAWAY SECTION
















EXISTING BASEMENT ACCESS




EXISTING FRONT WINDOW/HVAC VENT DETAILS






