


## 459 WEST BROADWAY: PROPOSED MASTER PLAN CRITERIA & DETAILS



- 3" standard black or white border;
- (contrasting sign content) within approved sign square footage and location on façade;
- No regulation of content within the designated sign space, as recommended by staff at public hearing;
- Term of the master plan permit shall be 10 years;
- Square Feet of exposed lot line wall: Approx. 4,426 sq ft
- Square Feet of the sign: Approx. 448 sq ft
- Sign Area: Approx. 10.12%



































#### PAINTED WALL SIGNS ON WEST BROADWAY






#### PAINTED WALL SIGNS ON WEST BROADWAY


