For over 10 years the majority investor has operated successful businesses without reports or action from the SLA, until 2012. See below a list of SLA related action.

7/2/2012 Cien Fuegos LLC received a notice of interview from the SLA. Principal and attorney attended a hearing to discuss a violation of subdivision 2 of section 106 of the ABC Law. Evidence was presented and our service tap cocktails were deemed legal under the ABC law.


8/14/2012 Cien Fuegos LLC received a Notice of Pleading from the SLA regarding violation listed above and noted a violation for lack of appropriate trade names (Gin Palace and Amor y Amargo). Appropriate forms were filed with the State (7.20.2012 7.11.2012) and the SLA. SLA then provided new liquor licenses showing all three trade names.

8/30/2012 Derossi Chelsea LLC received a letter from the SLA rescinding the approval of the alteration application noting that 30 day notice was not provided to the Community Board 3. 30 notice was mailed on 8/27/2012 and placed on the October agenda.

9/5/2012 Derossi Chelsea LLC received a Deficiency letter from the SLA discussing the requested hours of operation on our change of method application. Asked that we submit approved change of hours from the Community Board 3. This matter will also be discussed at the October meeting.
