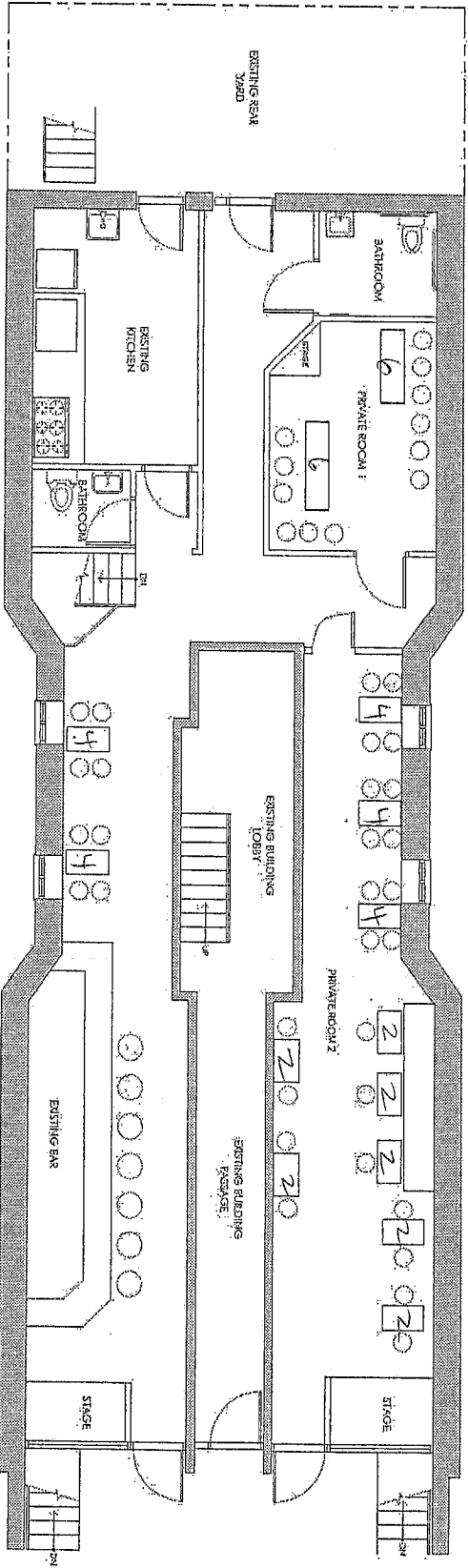


2 BASEMENT PLAN
