Good morning, NYCHA; and thank you for that warm welcome and for being with us on this very special occasion.

Today, we celebrate not just the Far Rockaways, but all of NYCHA and all of New York City. Just two weeks ago, we came together as an organization and as a community to brave one of the worst hurricanes in American history. I am grateful for the leadership of the Bloomberg Administration, from our friends on the City Council and in Albany for all they did to support NYCHA families before and after Hurricane Irene. From transportation to translation services to going door-to-door

to alert residents and help move New Yorkers to safety, you were truly outstanding.

I also want to thank our partners throughout City government—including the Office of Emergency Management (OEM), the NYPD, FDNY, and NYC Service for standing shoulder-to-shoulder with NYCHA throughout our response to Hurricane Irene.

Thank you, as well to our friends at the American Red Cross, the New York State Department of Environmental Conservation; and the US Coast Guard.

Finally, I want to say a very, very special thank you to NYCHA's employees. Property managers, engineers, Care Takers, secretaries, senior executives, housing assistants—employees from all across the Authority exemplified NYCHA at its finest, working tirelessly and selflessly, many volunteering their time, in the affected communities and in shelters to support residents in a time of great stress. I and the Board could not be prouder of our team for the tremendous heart and dedication they showed

throughout the week and weekend as Hurricane Irene approached and ultimately, made landfall, and we can't thank you enough. Today, together, we are renewing our commitment to each other and pledging that we will practice the old proverb, "Each one, help one." Only by helping each other and working together can we conquer the challenges our communities face. Let's not wait for another hurricane or extreme storm to realize how much we need each other. The time for action is now. I'm ready, NYCHA is ready and together we can weather any storm.
