Officer Finnegan and Officer McCoy are patrolling West Street when they receive a call concerning a past assault. When the officers arrive at the scene, they find a 30-year-old, Hispanic male named Jose, bleeding from the mouth. Officer Finnegan immediately calls for an ambulance over the radio. Officer McCoy asks Jose what happened. Jose states he was walking northbound on West Street when a man came up to him, punched him in the mouth, and stole his wallet. He gives a description of a 35-year-old, 6'10", Asian male, with long black hair, wearing a green cap, black shirt, and blue jeans. There are three witnesses to the assault. Officer Finnegan and McCoy begin to interview the witnesses.

*Witness 1:* "The man was walking northbound on West Street when an Asian guy who was about 6'10", wearing a black shirt, green hat, and blue jeans, came up to him and punched him in the mouth. He also had long black hair. After he punched him and took his wallet. He ran down Canal Street."

*Witness 2:* "The man was minding his business walking down Canal Street, when a tall white guy, about 5'10" feet walked up to him and punched him in the face. He was wearing a blue shirt and blue jeans, and had black hair."

*Witness 3:* "The man was walking northbound on West Street when an Asian guy wearing a black shirt and blue jeans came up to him and punched him in the mouth, and took his wallet. He had black hair."

#### **Burglary**

Answer questions 5 through 7 based solely on the information below:

Uniformed members of the service when coming into contact with an individual that may have apparently overdosed while using drugs and/or alleged opioids, may have to administer department provided Naloxone. Upon arrival at a scene when an individual may be suffering from, or has died from, a suspected drug overdose, officers should follow this procedure in the order given:

- I. Request an ambulance and render reasonable aid to suspected overdose victim.
- a. Request the response of a uniformed member of the service equipped with a Naloxone Kit, if not present at scene.
- b. Ascertain from witnesses if Naloxone was administered to individual prior to police arrival.
- II. If individual is unresponsive, administer Naloxone, if appropriate.
  - a. Request dispatcher to notify responding Emergency Medical Service (EMS) personnel that Naloxone was administered.
  - b. If individual is not breathing and has no pulse, Cardio Pulmonary Resuscitation (CPR)/Automated External Defibrillator (AED) should be administered.
  - c. If individual has not responded to Naloxone within three to five minutes, administer one additional dose of Naloxone.
  - d. Inform EMS personnel of any attempt to revive individual (e.g., CPR, AED, etc.) and number of Naloxone doses given.

Answer questions 12 through 15 based solely on the passage below:

Police Officers Kennedy and Hoover are dispatched to N/E corner of Clove Road and Hylan Boulevard, on March 22, 2018, at 9:01 A.M., in response to an assault in progress reported by a Mrs. Dansby. The officers arrive at the location at 9:07 A.M., to find an unconscious Mrs. Dansby laying on the ground with abrasions and swelling to the right side of her face. Officer Kennedy immediately calls for an ambulance using his radio. The officers observe a crowd of people around Mrs. Dansby, who are all stating they observed the assault.

At 9:09 A.M., EMS responds to the scene. They carefully put Mrs. Dansby on a stretcher and into the back of the ambulance. Officer Hoover asks Technician Ferguson what Mrs. Dansby's injuries were and if they will be able to interview her. Technician Ferguson states that Mrs. Dansby looks like she sustained a traumatic head injury due to being hit with a blunt object to the right side of her face, which resulted in her being left in a coma. They will have to rush her to the nearest hospital, Clove Lake Hospital, where she will be evaluated.

Officer Kennedy proceeds to interview the witnesses at the scene. The first witness, Frank Tartenbaum, states Mrs. Dansby was walking on the N/E corner of Clove Road and Hylan Boulevard when a man, driving his gold 2002 Toyota Camry, abruptly stopped the vehicle in front of Mrs. Dansby. He then got out of the car with a bat, and hit her on the right side of the face, ran back in the car and took off southbound on Clove Road. He was a Caucasian male, 5'10", heavy set, wearing a red shirt, and had short black hair.

Officer Kennedy interviews the second witness, Joan Collio. She states a man in a gold sedan stopped his car in the middle of Clove Road and Hylan Boulevard, got out with a bat, and hit Mrs. Dansby in the side of the face. He ran back in his car and took off on Hylan Boulevard.

Officer Kennedy transmits a description of the perpetrator to the rest of the officers on patrol using his radio: Caucasian male, heavy set, red shirt, short black hair, approx. 5'10". The officers conduct a canvass in the area for the male perpetrator.

Answer questions 16 and 17 based solely on the information below:

When a uniformed member of the service responds to a complaint involving a dangerous animal/dog, regardless of whether or not a person was injured by the animal, officers should follow this procedure in this given order:

- I. Have the Communications Section dispatcher request a unit from the Animal Care and Control of New York City respond to the scene, if the animal presents a danger or may have been left uncared for.
- II. Prepare DANGEROUS ANIMAL/BITE REPORT and, if required, AIDED REPORT (if a civilian is injured by the animal), in all instances in which responding to or becoming apprised of an incident involving an animal bite and/or dangerous animal and include the ICAD Incident number on forms.
- III. Request an Emergency Services Unit to respond to the scene, if response by A.C. & C. of New York City cannot be made expeditiously (fifteen to thirty minutes) or cannot be ascertained.
  - a. Deliver animal to an Animal Care and Control of New York City representative, if they respond to the scene.
  - b. Request patrol supervisor to respond to the scene.
- IV. Place kennel into the backseat of patrol car.
  - a. Transport animal to an Animal Care and Control of New York City intake center, and obtain a receipt once completed.



On Labor Day, Officers King and Jameson respond to a location where shots have been reported fired. Upon their arrival, the officers kick open the door to Apt. 7 of 1500 Bay Parkway. The officers observe a bald headed man, about 50 years old lying face up in his living room. The man is lying in a pool of blood. The officers tape off the crime scene, make all necessary notifications, and begin to interview five neighbors to find out if they saw or heard anything related to the death of Mr. Cain.

<u>Mr. Mulder:</u> "I was relaxing watching television when I heard the sound of a gunshot coming from Mr. Cain's apartment. I called the police right away. It was about 11 A.M. It's so sad about Mr. Cain. We would go out for drinks once a week. He was a good friend of mine. I last saw him this morning when he was going to the grocery store."

<u>Mrs. Scully:</u> "It's so sad, he was such a nice man. I last saw him around 11 A.M., when he was going to the grocery store. I spent the afternoon reading my book when I suddenly heard a gunshot coming from Mr. Cain's apartment. I immediately called the police. It was about 1 P.M. I'll miss him a lot."

<u>Mr. Scofield:</u> "It's so sad about Mr. Cain. He was so nice. I saw him about 8 A.M., when I came to ask him to come over for dinner. He was in a pretty good mood. He was drinking a glass of his 10-year-old scotch that he loved. About 11 A.M., I heard a shot from his apartment, and immediately called the authorities."

<u>Mrs. Burrows:</u> "I last saw Mr. Cain 9:45 A.M, when he was on his way back from the grocery store. He was the nicest man you will ever meet, but he was always lonely. I was cooking lunch in my apartment, when I heard a gunshot from his apartment. It was about 10:55 A.M."

<u>Mr. Heckler:</u> "It's such a shame about Mr. Cain. I last saw him this morning about 9 A.M., when I saw him walking in the hallway. About 10:50 A.M., I heard a gunshot coming from Mr. Cain's apartment. I called the police."





Police Officers often respond to scenes involving an emotionally disturbed person, abbreviated "EDP" (radio code 10-54 EDP). An emotionally disturbed person is a person who appears to be mentally ill or temporarily deranged and is conducting himself in a manner which a police officer reasonably believes is likely to result in serious injury to himself or others. When responding to a scene involving an emotionally disturbed person, officers should use the following procedure, in this order:

- I. Request "EDP location history" from dispatcher prior to arrival on scene, when responding to a call for service involving a possible EDP.
- a. Request Communications Section to contact the complainant while en-route to location, if possible, to obtain additional information.
- b. Alert the radio dispatcher that you have arrived at the scene with radio code "10-84".
- c. Carry three-foot polycarbonate shield with door bag (door rope/door wedge) affixed, if available.
- II. Request and/or ensure the response of:a. Patrol supervisor.
- b. Additional personnel/equipment (e.g., Emergency Service Unit, Ambulance etc.), if necessary.
- III. Attempt to isolate and contain the EDP while maintaining a zone of safety (20 feet) until arrival of patrol supervisor and Emergency Service Unit personnel.



Answer questions 36 through 39 based solely on the paragraph below:

On July 4<sup>th</sup>, 2018, at 11:30 P.M., Police Officers James and Kerry are dispatched to 721 West End Avenue, Apt 4, in regards to a past burglary. At 11:45 P.M., the officers arrive at the apartment where they observe the door moldings and hinges have been forced off the door. Samantha Telly, the tenant who lives in apartment 4 greets the officers. She tells them that she left her apartment around 10:00 A.M., on July 4<sup>th</sup>, 2018, and returned home around 11:20 P.M. She had spent the day with a friend celebrating the holiday.

Officer James urges Mrs. Telly to refrain from touching anything in the apartment. He notifies the patrol supervisor that the apartment shows signs of being burglarized. He then uses his department radio to request the Evidence Collection Team to respond to the scene to gather prints. As Mrs. Telly is searching her apartment she realizes her DVD player, and a shoe box with about \$2,000 from under her bed is missing.

The officers escort Mrs. Telly out of the apartment, and ask her to wait until the Evidence Collection Team responds to go back in. She agrees to leave the apartment.

Officers Kerry and James agree to interview the various tenants on Mrs. Telly's floor to see if they witnessed anything out of the ordinary. Officer Kerry knocks on the door of apartment 3, but nobody answers. He then moves to apartment 2, where he is greeted by Mr. Doland. Officer Kerry explains the situation, and asks if he had seen anything out of the ordinary throughout the day. Mr. Doland states he saw one man coming in and out of apartment 4 at 9:00 P.M. He thought Mrs. Telly was having a 4<sup>th</sup> of July party, so he didn't think anything of it. He described the perpetrator as a Hispanic male, 6'07", 250 lbs., wearing a purple shirt and black sweat pants.

Officer James knocks on the door of apartment 5, and is greeted by Mrs. Chau. He explains the events of the day, and asks if she had seen anything. Mrs. Chau stated she heard banging for about 10 minutes at 9:00 P.M., but was afraid to look who it was. She states Mrs. Telly and her boyfriend argue a lot, so she assumed she had kicked him out of the apartment, and he was the one banging on the door.

The Evidence Collection Team arrives at the scene around 12:15 A.M., and proceeds to take fingerprint samples. Officers Kerry and James begin the report for burglary.
