The Mayor's Office to End Domestic and Gender-Based Violence (ENDGBV) Training Team designs and facilitates interactive trainings tailored to service providers in their roles at City agencies and community based organizations (CBOs). We work with these agencies and CBOs to identify needs for initial, and ongoing advanced trainings. We also offer support to the providers we work with on reviewing and developing their existing policies and protocols around domestic and gender-based violence. We are committed to working with each provider to make sure that the training(s) we provide are current, informative, and engaging.

What trainings does the Training Team offer?

Our signature training is Intimate Partner Violence 101, which covers a variety IPV related topics, including:

- Best Practices
- Systems Response to IPV

How long is the IPV 101 training?

The IPV 101 training is 3.5 hours long. A more in-depth one-day training is also available. This training can also be given in two shorter sessions over two days.

Who can attend an advanced training?

Anyone who has completed the signature IPV101 training can attend an advanced training.

Is IPV 101 still a prerequisite to the advanced trainings if I have previously taken an IPV or DV training?

Yes, IPV 101 is a pre-requisite to taking any advanced course.

Is IPV 101 a mandatory training for all City and CBO employees?

Check with your agency to see if you are mandated to attend IPV 101 training.

Training Logistics

How can my organization schedule trainings?

Organizations interested in scheduling staff trainings should [complete the online training request form](#). Once your request is received, we will send you an email indicating the availability of trainings on your requested date(s).

Is there a cost to facilitate trainings?

No, all trainings are free of charge.

Where are trainings held?

We travel to organizations throughout the five boroughs. Locations must be accessible by New York City public transportation (such as subway or bus). We may have a limited capacity to host trainings, as needed.

When can trainings take place?

Trainings are scheduled Monday to Friday, between 9:00 a.m. to 6:00 p.m.

How far in advance should trainings be scheduled?

Scheduling depends on availability. We recommend scheduling trainings at least 2-3 weeks in advance.

Do you offer CLE, CNE, CME, or CEU credit?

Some trainings may be eligible for continuing education credits, if the hosting agency is a CLE, CNE, CME, or CEU provider. Certificates of completion are available upon request.

How many participants are allowed in each training?

Trainings are limited to 10-40 participants.

What if we have a group of more than 40 people?

A larger group can be accommodated by facilitating separate sessions for smaller segments of the group, on the same day or over multiple dates.

Do you require any Audio/Visual equipment, such as a projector?

Our trainings are PowerPoint based. We typically use a projector and a PC with a USB drive. While access to the internet not required, it enables enhanced opportunities for engagement throughout the training.

Other Questions

Who leads these trainings?

Trainings are generally facilitated by two Training and Curriculum Specialists. Our Specialists have years of experience in the field, and provide expertise in the intersections of IPV and gender-based violence.

What teaching methods are used during the trainings?

The Specialists are skilled facilitators and participant engagement is encouraged throughout the trainings. Trainings are designed to transfer knowledge into practice by allowing participants to use realistic case scenarios and role plays tailored to their workplace. We also provide additional resources and materials at each training.
