The investment objective of the Small-Cap Equity Fund is to provide long-term growth of capital by investing primarily in the stocks of smaller companies. Small-cap stocks offer the opportunity for greater long-term capital appreciation. In the short-term, however, these stocks may display substantial volatility (risk as measured by standard deviation).

Investment Guidelines

The Small-Cap Equity Fund will invest primarily in small and medium capitalization domestic companies listed on the U.S. exchanges or traded on the NASDAQ or over the counter.

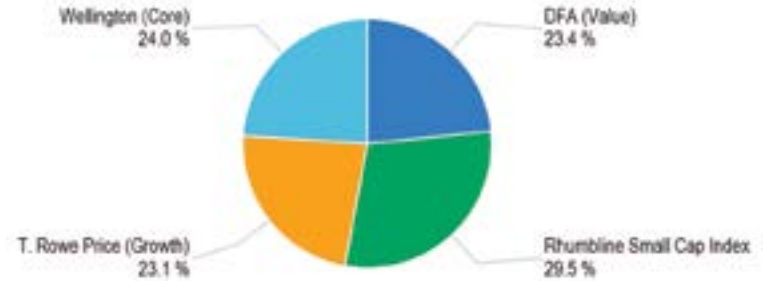

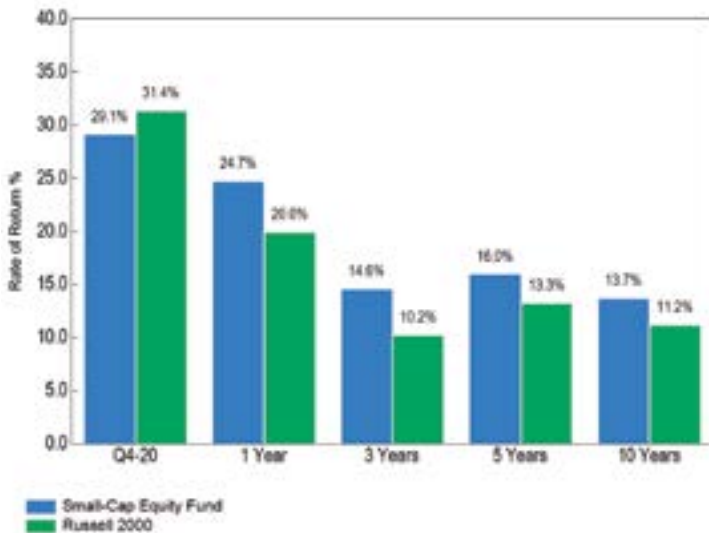

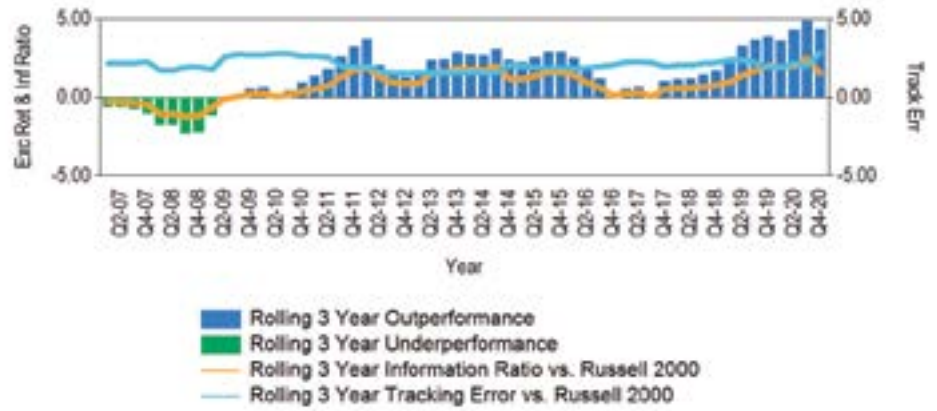

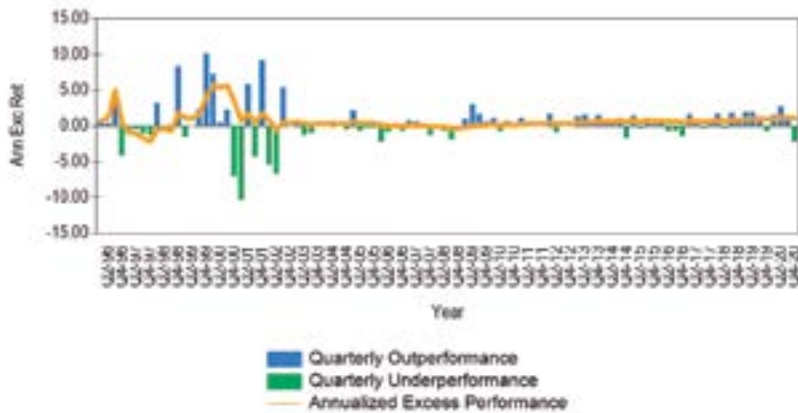

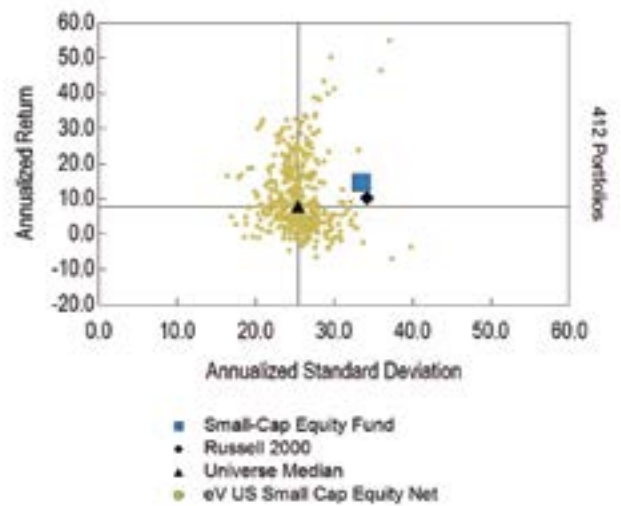
Three Year Rolling Performance, Information Ratio and Tracking Error

The above analysis shows the portfolio risk (measured by standard deviation) vs. the portfolio return. The small cap equity fund has a higher standard deviation and return than the universe median, and the Russell 2000 Index. On a risk adjusted basis, the small cap equity fund has beat the benchmark over the past three years.
