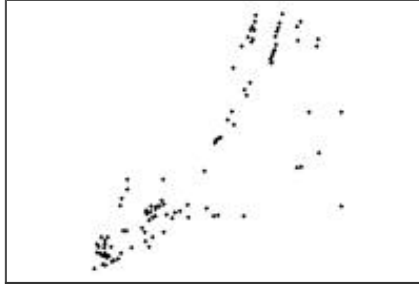

Recognized Ecological Complexes (RECs) are a special area designation of the NYC Waterfront Revitalization Program.

### Description

Recognized Ecological Complexes (RECs) are defined and mapped in the Waterfront Revitalization Program. RECs are special area designation that assist WRP consistency review. The RECs are clusters of valuable natural features which are more fragmented than those in the SNWAs and are often interspersed with developed sites. Many of these areas are protected parkland or sites identified as priority acquisition or restoration sites by local, state, and regional plans. Many are substantially environmentally deteriorated and require an active approach to restoration.
