

MEMORANDUM OF UNDERSTANDING

MEMORANDUM OF UNDERSTANDING BETWEEN THE NEW YORK CITY POLICE DEPARTMENT AND THE NEW YORK CITY DEPARTMENT OF PROBATION FOR NYPD BASIC FIREARM INSTRUCTOR COURSE

This Memorandum of Understanding (MOU) is between the City of New York, acting by and through the New York City Police Department ("NYPD") with offices at One Police Plaza, New York, New York, 10038, and the New York City Department of Probation ("Probation") with offices at 33 Beaver Street, New York, New York, 10004, to provide NYPD Basic Firearm Instructor Course training ("FIC training") for up to two (2) Probation employees.

WHEREAS, Probation has requested that the NYPD permit up to two (2) Probation employees to attend the NYPD FIC training.

WHEREAS, The NYPD has agreed to permit up to two (2) Probation employees to attend the NYPD FIC training.

NOW, THEREFORE, the parties agree to the terms which follow:

TERM:

This agreement shall become effective immediately upon the execution by both parties. It shall remain in effect until it is terminated by either or both parties.

TRAINING SESSIONS:

NYPD Firearms and Tactics Section instructors will conduct the FIC training for up to two (2) Probation employees. This course is held on twelve training days with a total of eighty four (84) training hours. The dates for the training sessions will be exclusively decided by the NYPD. Probation employees will be permitted to attend this course as seats become available. All training will be held at the NYPD Rodman's Neck Outdoor Range. Those Probation employees who do not meet and maintain the NYPD's standards for the FIC training shall not be considered to have successfully completed the training sessions and may be terminated from the FIC training at any time. Decisions on whether a Probation employee has satisfactorily completed the NYPD's FIC training sessions shall be at the sole discretion of NYPD personnel.

INDEMNIFICATION:

The Parties agree that the City of New York is the indemnification agent for both agencies.

ACKNOWLEDGMENT:

Probation acknowledges that a complete background check has been conducted for each Probation employee who will be enrolled in the MOI Course, and that each Probation employee has passed the background check and has been approved by the Probation for law enforcement training.

The NYPD and Probation acknowledge that the MOI Course is approved by the New York State Division of Criminal Justice Services. The parties also acknowledge that the Course is limited in scope and is not intended to train participants to assume full police/law enforcement duties. The Course is not a substitute for a complete police/law enforcement training course such as the training given to New York City Police Department recruits.

RECORDS TO BE MAINTAINED BY THE NYPD:

The NYPD shall retain all training records of Probation personnel and provide copies to Probation upon request.

CONTROL OF NYPD PERSONNEL:

All NYPD personnel who participate in and administer the training shall remain under the supervision and control of the NYPD.

AMENDMENTS:

Any amendments to this agreement must be in writing and signed by both of the parties.

TERMINATION:

This agreement may be terminated by either party upon 30 days written notice to the other party.
This MOU shall not be modified orally.


