## District Manager Report February 21, 2024

February is Black History Month. Think of the sacrifices people made before you.

### **Section 8 Applications**

Recipients of Section 8 Vouchers pay no more than 30% of their income toward rent, while Section 8 covers the rest up to a certain "fair market" threshold determined by the federal government. Recipients must be a U.S. Citizen or have legal permanent residency and can use their vouchers in all 50 states and U.S. territories, as long as they find a landlord willing to accept it. The federal Department of Housing and Urban Development issues the vouchers to local agencies, like NYCHA, to disperse and oversee.

In New York, it's illegal for a landlord to reject a prospective tenant because they'll pay rent with a Section 8 voucher or another subsidy.

The lack of enforcement will be a problem for new Section 8 recipients because people have only 120 days to find a place to live after receiving the voucher before they lose it.
