  - o BM Bonnie Huie: When?
  - o A: 5- year and 10- year plan. Different times on different phases.
  - o BM Alain Berrouet: Did MTA President apologize for the earlier meeting with 48-hour notice?
  - o BM Natasha Williams: Were their metal detectors at the meeting?
  - o A: Yes.
  - o BM Nantasha Williams: Did they have them at other meetings?

Reviewed, motion to accept. Seconded. Unanimous vote.

### **Public Speaking**

**Bob Friedrich:** Queens Civic Congress (BM Richard Hellenbrecht, a member) established to keep good quality in our neighborhoods. Vehemently opposed to the plan to close Rikers Island. Closing will only accommodate 5,500 prisoners. Currently 8,500 in Rikers. For the plan to succeed, 3,000 less have to be released back into our local

communities. They are supposedly non-violent... (lists various crimes committed). Neighborhood detention centers could not accommodate any increase in crime. Rikers Island is the ideal location as it is surrounded by water.

There has been no community involvement in this plan. The price to close this facility is enormous. He urges QCB13 to join the Queens Civic Congress in opposing this initiative.

BM Bonnie Huie: Where would they be? A: The Queens House of Detention is to be torn down with 35 story building built to accommodate more prisoners.

BM Alain Berrouet: Is there a reason no prisons are planned for Staten Island? Bob Friedrich: Only speaking for Queens, will not speculate.

Q: Two types of people in jail; waiting for trial or waiting for sentence. Other 3K overflow; how many cannot make bail and how many waiting to go upstate?

A: Average number of prior felony arrests are multiple felonies and misdemeanors.

Board Chair ends line of questioning.

Art Russell: Concerned about the status of his community. Lived there 35 years. Previously, police would help the elderly. Exception was crime and disruption. Now this is reversed. Presently, new neighbors have different values. Community has houses oversaturated with cars. No longer available street parking. Cones put in the street. Requests that for elderly, disabled special parking allocated.

BM Bryan Block: What community?
Art Russell: Laurelton.

# Deputy Inspector Netis Gilbert, Commanding Officer of the 105 Precinct

- Overview:
  - o 28-day down 17 crimes
  - o 122 crimes, 222 arrest
  - o Crime driven by grand larceny
    - Folks leave valuables visible in car
    - Cars are not locked (Secure your vehicle!)
  - o 13 domestic violence calls
  - Grand Larceny auto Honda a favorite
    - People leave keys and fobs in the car
    - Be careful with autostart
      - Down 13 robberies
      - Down 15 felony assaults
- Needs help from the community for proper development.

- Sector Report:
  - o Adam (Rosedale and Springfield Gardens) up 1
  - o Boy (Laurelton) down 4
  - o Charlie (Cambria Heights) Flat
  - o David (Queens Village) down 16
  - o Eddie (Bellerose, Glen Oaks and Floral Park) down 1
- Arrest in Laurelton who were surveilled during burglary.
- Thanks Rosedale Civic for invitation to dinner dance. Helps Police Department see you in your own light.
- Safe Communities Projects:
  - Abandoned unkempt homes
    - Drugs
    - Squatters
    - Clean up outside
- Influx of residents in community. Very conscious of number of cars. Wants to meet with Mr. Russell.
- Camera registration:
  - o Helps in criminal investigations
  - o Community partner
- Commercial trucks:
  - o 452 illegal overnight summonses
  - o 32 booted
  - Utilize NCOs
  - o Towed 200 derelict vehicles
    - Change plates
    - Cannot park more than 7 straight days
- Ride-Along Program:
  - o Ride in sector car
  - o With a vest and go on radio calls with patrols

BM Corey Bearak: Limos in Bellerose taking up spots. A: Let's sit down and talk. Bring highway safety unit.

BM Jerry Wind: Praise to Sector Eddie as trucks on Hillside Avenue disappearing.

Sean Williams: How to get rookies into the meetings?

A: She has them attending these meetings. Introduces Sergeant Sophia Clarke. Both were community affairs officers.

Evette Strong: Does this affect any public parking?

A: No. Part of the present landscaping.

### **District Needs**

District Manager presents priorities (handout to all Board Members).

Changes made to Expense Priorities:

#2 – Deleted (Sewer plan for Meadowmere and Warnerville). This area is at sea level according to DEP. New paving more appropriate.

#8 – Deleted (More frequent hazardous waste disposal events). Duplicative of Expense #4.

#9 – Deleted (Enforcement of illegally parked 18-wheelers on Springfield Boulevard). This issue is presently already being aggressively addressed.

#10 – Deleted (Improve maintenance of Rockaway Boulevard, western edge, between Farmers and Brookville Boulevards). This is not Department of Parks & Recreation property; it belongs to the Port Authority of New York & New Jersey.

Added: Double-yellow lines painted on the ground on the Grand Central Parkway Service Road between Little Neck Park way and Marcus Avenue.

Changes made to <u>Capital Priorities</u>:

#11 - Deleted (A STOP sign was installed near PS 195Q).

#13 – Deleted (Breininger Playground already has a priority #2).

#15 – Deleted (New restrooms at Idlewild Park will not be constructed in the near future as a new building just broke ground at Idlewild Park).
