Karesia Batan welcomed everyone to the Arts and Cultural Affairs Committee meeting.

The Arts and Cultural Affairs Committee had a small discussion on MTA Transit art at the subway stations. The MTA department that handles transit art is now called Arts & Design. That department is aware of when a station is under reconstruction. They do calls twice a year for artists.

Karesia Batan introduced Dirk McCall, Executive Director of Sunnyside Shine BID

• Dirk McCall spoke about a grant that is partially funded by the City, National Grid, and a few foundations.

"Serving the Communities of Long Island City, Sunnyside, Woodside, and Maspeth"

- Sunnyside Shine BID was selected as a grant recipient to help with improving the public space, engagement with the community and art installations.
- They are presently looking at these locations for use of this grant, Lowery Plaza, Bliss Plaza and Sabba Triangle.
- Dirk McCall has a survey to get feedback on what the community wants in these locations. Increased lighting is mentioned for two of the locations.
- Dirk McCall mentioned that Sunny Pride will be on Friday, June 14th, 2024.

Karesia Batan introduced committee member Kenny Greenberg and Angel Hart of LIC Partnership to discuss the Creative Lighting Initiative Project sponsored by NYC Small Business Services. (*Pergola Presentation is attached*)

- Angel Hart explained that LIC Partnership received a Small Business Services grant which was a commercial lighting grant. The grant is for creative lighting projects in public spaces. The location selected for the lighting installation will be at Vernon Mall and Gordon Triangle.
- Kenny Greenberg shared with the committee what the design will look like.
- It will be 2000 color changing LEDs that will be programmed to various patterns, colors and movements. A symphony of light.

- The lights will not be on 24/7.
- The exhibit should be displayed in June 2024 for at least 7 months.
- LIC Partnership will be maintaining this exhibit.

Karesia Batan requested Dirk McCall to give an update on the Bliss Theater.

- The Bliss Theater was created in 1930.
- It was a movie theater until 1964.
- The Pickman Family then sold it to the Jehovah Witnesses.
- The building is an Egyptian style building and in great condition. There was a request that this location be considered for Landmarking.
- The building is being sold and they are asking \$16 million for the site.
- There is a lot of communication with the elected officials and CB2 to try and save the theater.
- Karesia Batan stated that a letter was drafted at the last community board meeting requesting that the owners work with the community in terms of prioritizing bids that do want to preserve the space and prioritize it as a cultural arts center. The letter will also state that landmarking be looked into and also stated the historical significance.
- Thalia Spanish Theater is willing, able, and interested to run the space.
- So far 40 bids are interested in the site.
- The Jehovah Witness plan to stay there and operate for another year.

The first program will be May 6th, 2024. It is a panel situation where different people talk about various aspects of public art in public space.

Karesia Batan introduced Alexa Gonzalez a new community board member. Alexa Gonzalez is from High Public Space a place making studio in LIC.

Old / New Business

Karesia Batan mentioned that the Queens Borough President's office has a non-profit network that is very active. It is mainly information and meetings and resource events that are communicated through e-mail. Karesia Batan shared with the committee that there is a link on the Parks Department website that puts together all the spaces that are eligible for art activations, open RFPs and a map that has every public art display currently in the five boroughs. The first round of murals at the Ottomanelli's deck along the LIC waterfront was unveiled last year; they just completed their selection for the second round.

A new poetry installation was installed at Lou Lodati Park in Sunnyside.

The mural along Doughboy Park was completed last summer and Karesia invited attendees to visit it.

Karesia Batan shared with the committee the merger of Queens Council on the Arts with the Boys and Girls Club in Astoria. She had a discussion with the committee about the history of Queens Council on the Arts.
