# **Public Safety**

Stephen Cooper, Chair and Danielle Brecker, Co-Chair of CSPS Committee, and Morry Galonoy, CB2 Chairperson intend to meet with the 108<sup>th</sup> Pct. to discuss the crime issue on the waterfront at Hunter's Point So. Park and see what the community can do.

A committee member brought up a chronic problem in Blissville, Maspeth, LIC where cars are being abandoned with no plates. 311 has been called, but nothing is being done. Another issue of concern is that on Review Avenue a lot of trailers are parked on this Avenue for months some with plates, some with no plates. There is a lot of federal rules concerning this asfaras if license plates are from another state. Debra Markell Kleinert stated that a picture to the CB2 office would be helpful and reported that if the vehicle is an abandoned vehicle with no plates, Sanitation can remove it as a tag and tow. If it has plates, then it is under the jurisdiction of NYPD.
