### TLC HOSTS INFORMATIONAL MEETING WITH FEMA/SMALL BUSINESS ADMINISTRATION ON WEDNESDAY, OCTOBER 10, 2001 CHANGES IN VEHICLE RETIREMENT PROCEDURES ARE ANNOUNCED

Business owners licensed and regulated by the TLC and/or their representatives are invited to an informational meeting hosted by the TLC and featuring the Federal Emergency Management Administration (FEMA) and the U.S. Small Business Administration. Information regarding the availability of low-interest loans for physical and economic losses incurred as a result of the WTC emergency will be provided. This informational meeting will be held on Wednesday, October 10<sup>th</sup>, 2001 at 11:00 a.m., at the TLC Woodside facility located at 24-55 Brooklyn-Queens Expressway West. Because seating is limited, those wishing to attend should call (718) 267-4523 to reserve a place before 5:00 p.m., Tuesday, October 9<sup>th</sup>, 2001.

A four-month extension is now being made available to owners whose vehicles are scheduled to retire during the current inspection cycle. The extension will only be granted to those medallion owners who provide proof of purchase of a new vehicle within the current inspection period, but for which delivery is not expected until after the date of vehicle retirement.
