

Frequently Asked Questions

1. What is the TLC Driver License Renewal Course?

The TLC Driver License Renewal Course is a new continuing education course for TLC-Licensed Drivers with licenses expiring on or after January 1, 2022. The purpose of the course is to provide professional and practical hands-on training to support their work as professional drivers and enhance public safety.

2. Who needs to take the TLC Driver License Renewal Course?

The course is for TLC-Licensed Drivers with licenses that expire on or after January 1, 2022. Paratransit and commuter van operators are not required to take the TLC Driver License Renewal Course as they have different rules and regulations.

3. I am a TLC-Licensed Driver, when should I take the TLC Driver License Renewal Course?

You should complete the course 90 days before the expiration date of their TLC Driver License.

4. Where can I take the TLC Driver License Renewal Course?

You may take the TLC Driver License Renewal Course with one of the Authorized TLC Education Providers starting October 1st.

5. How much does the course cost? And how do I pay for the course?

The TLC Driver License Renewal Course is an additional fee and will pay the Authorized TLC Driver Education Provider directly for the cost of the course.

6. I am a TLC-Licensed Driver and have been driving for many years. Are there any exemptions or waivers for the TLC Driver License Renewal Course?

There are no exemptions or waivers for the TLC Driver License Renewal Course. All TLC-Licensed Drivers are required to complete the course regardless of their prior education status.

7. What happens if I do not take the Renewal Course before my TLC Driver License expires?

The TLC will not renew your TLC Driver License because you did not complete all the renewal application requirements.



8. What happens if I do not take the Renewal Course during my license renewal period? Can I still renew my TLC Driver License?

Yes, you can take the course during the 180-day late renewal period and will be required to pay the \$25.00 late renewal fee.

9. How do I get credit for the course? How will TLC know I took the course?

The Authorized TLC Education Provider will send your course completion information to the TLC, which will then be uploaded to your license record.

10. How long is the course?

The course is six (6) hours long.

11. I have been a TLC-Licensed Driver for many years and did not take the 24-HR TLC Driver License Education Course when I first got my license. Do I still have to take the TLC Driver License Renewal Course?

Yes, you are required to take the TLC Driver License Renewal Course at the time of renewal. Although you may not have been required to take the 24-HR TLC Driver Education Course when you first got your license, all Licensees are required to take the Renewal Course every three years.

12. Do I need to take the Renewal Course every time I renew my license?

Yes, TLC-Licensed Drivers will be required to complete the TLC Driver License Renewal Course every three years prior to the expiration date of their license.
