

**MINUTES OF THE MEETING OF THE FINANCE COMMITTEE OF
THE NEW YORK CITY TRANSITIONAL FINANCE AUTHORITY**

April 10, 2012

A meeting of the Finance Committee (the “Committee”) of the New York City Transitional Finance Authority (the “Authority”) was held on April 10, 2012 at approximately 4:30 p.m. at 75 Park Place, Room 6M4, New York, New York.

The following Committee member was present:

Mark Page, Director of Management and Budget of The City of New York (the “City”); and

the following Committee members were represented by their designees:

John C. Liu, Comptroller of the City, represented by Carol Kostik;

Christine C. Quinn, Speaker of the City Council, represented by Raymond Majewski;

David M. Frankel, Commissioner of Finance of the City, represented by Dara Jaffee; and

David Burney, Commissioner of the Department of Design and Construction of the City, represented by Michael Garrett;

constituting a quorum of the Committee. Kathy Blyn served as secretary of the meeting.

Also in attendance were members of the public, officers of the Authority and employees of various agencies of the City and the State of New York.

The meeting was called to order by Ms. Kostik, the Chairperson of the Committee.

Approval of Minutes

The first item on the agenda was the approval of the minutes of the meeting of the Committee which occurred on December 2, 2011. A motion was made to adopt the resolution set forth below with respect to such minutes. The motion was seconded and, there being no objections, approved.

WHEREAS, the Finance Committee has reviewed the minutes of its meeting held on December 2, 2011; it is therefore

RESOLVED, that the minutes of the meeting of December 2, 2011 be, and they hereby are, approved.

Recommendation to Board to Approve Issuance of Fiscal 2012 Series E Future Tax Secured Bonds

The second and final item on the agenda was a recommendation to the Board of Directors that it approve the issuance of the Authority's Fiscal 2012 Series E Future Tax Secured Bonds (the "Bonds") consisting of a subseries of tax-exempt bonds and a subseries of Qualified School Construction Bonds ("QSCBs"). Ms. Kostik briefly described the structure, terms and marketing of the Bonds. A brief discussion ensued. A motion was made to approve the resolution set forth below with respect to such recommendation. The motion was seconded and, there being no objections, approved.



WHEREAS, the Finance Committee has received and reviewed a proposal for the issuance of Fiscal 2012 Series E Future Tax Secured Bonds; it is therefore

RESOLVED, that the Finance Committee recommends to the Board the approval of the issuance of Fiscal 2012 Series E Future Tax Secured Bonds.
