SUBJECT: Veterans Services Report for 2015

Local Law 23 of 2015 requires that specified agencies report annually to the City Council, the Commissioner of Veterans' Services and the Veterans' Advisory Board on the number of veterans' preferences applied for and provided by those agencies. The goal is to determine the degree to which veterans avail themselves of existing services designed to help them secure housing and other available benefits from the City, and to identify areas where City government should strengthen or modify services to meet the needs of veterans living in the City. The Mayor's Office of Operations was designated to receive the agency data and prepare the yearly report.

Attached please find the Veterans Services Report for calendar year 2015. This report reflects the second yearly report following enactment of Local Law 23 in March 2015 and the first report since Mayor de Blasio signed the law creating the Department of Veterans' Services in December 2015. The annual figures are provided by agency and by the category of benefit. In addition, this year agencies have also provided disaggregated information by the veterans' borough of residence wherever available.
