NYC Launches Leadership Association to Support Veteran Entrepreneurs

New York – The New York City Department of Veterans' Services (DVS) announced today the launch of the Veteran Business Leadership Association (VBLA) to empower and support Veteran business owners across the city. The VBLA is a specialized program that offers monthly educational workshops, networking opportunities, and one-on-one support to help Veterans grow their businesses. Workshops will focus on business development, government contracting, and Service-Disabled Veteran Owned Business (SDVOB) and Minority and Women-Owned Business Enterprises (M/WBE) certification support.

"Our Veterans put their lives on the line and fought for all of us, and now it's our time to do our small part and fight for them," said **New York City Mayor Eric Adams**. "This leadership program will empower and support New York City's Veterans by providing them with the tools to grow their businesses and succeed. As a former NYPD officer, I know what it is like to answer that higher calling, and the sacrifice and resilience shown by each of our Veterans inspires us every day. Now is our time to support our Veteran small business owners and help them recover from the COVID-19 pandemic."

This program was created to provide support to Veteran small business owners as New York City continues to successfully recover from the pandemic. The VBLA also responds to recommendations made in the "Roadmap for Supporting Veteran Owned Businesses" report that was developed by the Department of Small Business Services and the Mayor's Office of Contract Services in 2014 to promote economic growth among Veteran entrepreneurs.

The program kicked off with a roundtable discussion that was held earlier this week on Monday, April 11th at Brooklyn Borough Hall with roughly 50 Veteran small business owners present. Attendees heard from DVS Commissioner James Hendon, SBS Commissioner Kevin D. Kim, Brooklyn Borough President Antonio Reynoso, and other leaders in the Veteran entrepreneurship space.

In July of 2021, DVS launched another effort to support Veteran entrepreneurs—VetBizNYC. VetBizNYC is an interactive map that showcases more than 300 Veteran owned businesses to help drive commerce throughout the five boroughs. The map also includes information about each business' certification status, in addition to contact and website information.

Members of the VBLA are encouraged to also register their businesses on the VetBizNYC map to promote their enterprises more broadly.
