COMMISSION DIRECTIVE

Dear Licensee:

Customer register data and the notarized, signed certification form for the period July 1, 2014 through December 31, 2014 is due to the Commission no later than January 30, 2015. All fields in the customer register must contain complete and accurate information. Customer register data must be submitted as a Microsoft Excel spreadsheet along with the notarized, signed certification form.

You can obtain customer register format files on our website http://www.nyc.gov/html/bic/html/trade_waste/customer_register.shtml. If you are unable to obtain the files from our website, feel free to contact the Commission and we will mail out a CD with the files to you.

Customer register data and the notarized, signed certification form can be submitted on floppy diskettes, CD/DVD, and electronically via email to customerregister@bic.nyc.gov. Please write your company name and the reporting period on every diskette or CD/DVD that you submit.

If you collect medical waste, recycle tires or shred paper, you **must** submit a customer register. Medical waste haulers, tire recyclers and paper shredders are **not exempt** from the customer register requirement. Also, grease haulers must submit grease customer registers.

YOU MUST RESPOND TO THIS DIRECTIVE. Your failure to respond to this Commission Directive will be considered violations of Title 17, Sections 1-09 and 5-03(g) of the Rules of the City of New York. **The failure to comply with this Commission Directive to submit customer register data may result in penalties of up to \$10,000 for each violation.**

EXEMPTION FROM CUSTOMER REGISTER:

You must submit a **notarized** letter on company letterhead with the date and reference to the current reporting period (July 1, 2014 – December 31, 2014) along with the notarized certification stating the reason(s) why you believe you are exempt from the customer register requirements. You **may** be exempt from the customer register requirements if:

- You do not have any customers in New York City; or
- You only perform construction and demolition work;

You must submit a letter for this reporting period even if you have submitted a letter for exemption from customer register requirements in the past. The letter and certification must be submitted to the Commission on or before January 30, 2015.
