VISION ZERO PRIORITY


Queens Priority Geographies

Vision Zero

- Multi-agency effort to reduce traffic fatalities in NYC
- Borough Action Plans released in 2015
- Priority Intersections, Corridors, and Areas identified for each borough

Northern Blvd


- Northern Blvd and 146 St is a Vision Zero Priority Intersection
- Northern Blvd is a Vision Zero Priority Corridor
- Located in a Priority Area



PROJECT LOCATION

Northern Blvd: 146 St – 147 St

- Mixed use commercial and residential area
- Located in the Flushing Senior Pedestrian Focus Area
- Commercial corridor with multiple drive-thrus and parking lots at 146 St and 147 St
- Countdown clocks and leading pedestrian intervals installed at 146 St and 147 St crossing Northern Blvd in 2016 and 2017



PROJECT BACKGROUND

Northern Blvd: 146 St – 147 St

- Safety improvements requested by The Shield Institute, a private school for children and adults with Autism spectrum disorder
- Project area used by students accessing Flushing High School, Junior High School 189 and The Shield Institute
- 1 pedestrian fatality and 2 severe injuries (2012-2016)
- 61% of pedestrian injuries from left turn crashes







EXISTING CONDITIONS: NORTHERN BOULEVARD AND 146 ST





PROPOSED SAFETY IMPROVEMENTS: NORTHERN BOULEVARD AT 146 ST AND 147 ST



PROPOSAL DETAIL: RELOCATE BUS STOP NORTHERN BOULEVARD AT 146 ST AND 147 ST

- Shift bus stop for Q13 & Q28 from driveway to the sidewalk at 146 St
- Provides safer curbside access
- Removes conflicts with passengers and drivers in parking lot driveway
- Bus stop replaces four parking spaces




PROPOSED CONCRETE PEDESTRIAN REFUGE ISLANDS: NORTHERN BOULEVARD AND 147 ST

PROPOSED LEFT TURN BANS FOR ALL VEHICLES: NORTHERN BOULEVARD AT 146 ST AND 147 ST




-  Banned turn

SUMMARY OF PROPOSALS

Northern Blvd: 146 St – 147 St

1. Northern Blvd and 146 St:


- Left turn ban from eastbound Northern Blvd onto northbound 146 St to reduce pedestrian and vehicle conflict
- Add hardened centerline in flush median in east leg to control vehicle turns

2. Northern Blvd and 147 St:

- Add concrete pedestrian refuge island in east and west legs of intersection
- Left turn ban from eastbound Northern Blvd onto NB 147 St to reduce pedestrian and vehicle conflict
- Relocate Q13/Q28 bus stop out of driveway to sidewalk at 146 St

3. 147 St and 37 Ave:

- Mark high visibility crosswalk
