## NYC VCP Cleanup Plan Remedial Activities to Begin

The New York City Office of Environmental Remediation (OER) is providing this Fact Sheet pursuant to the New York City Voluntary Cleanup Program (VCP). OER has approved the Remedial Action Work Plan (RAWP) submitted by 186 Greenpoint Avenue, LLC for 186 Greenpoint Avenue, Brooklyn, New York (Block 2575, Lot 5). The remedial work will begin in November 2015. The RAWP can be reviewed electronically at the document repositories identified in the box at left.

### Site Description:

The 3,725 square-foot site is vacant but most recently contained a 2-story residential building and a garage. The proposed development consists of a 5-story mixed-use commercial and residential building with a cellar and rear yard.

### Summary of the Remedy:

The remedial action for 186 Greenpoint Avenue is a Track 4 Site-specific cleanup. The specific elements of the proposed remedial action include:

- Preparation of a Community Protection Statement and performance of all required NYC VCP citizen participation activities according to an approved Citizen Participation Plan;
- Performance of a Community Air Monitoring Program for particulates and volatile organic carbon compounds;
- Establishment of Site-Specific (Track 4) Soil Cleanup Objectives (SCOs);
- Excavation and removal of soil/fill in excess of SCOs;
- Transportation and off-site disposal of all soil/fill material at permitted facilities in accordance with applicable laws and regulations;
- Collection and analysis of end-point samples to determine if the remedy attains Track 4 SCOs;
- Construction and maintenance of an engineered composite cover;
- Installation of a vapor barrier system beneath the building foundation slab and behind foundation sidewalls to grade;
- Submission of an approved Site Management Plan (SMP) in the Remedial Action Report (RAR) for long-term management of residual historic fill;
- Submission of a RAR that describes the remedial activities, certifies that the remedial requirements have been achieved, defines the Site boundaries, and describes all engineering and institutional controls to be implemented at the Site; and
- Continued registration with E-designation for the property

Cleanup activities are scheduled to begin in October 2015 and are expected take approximately two month to complete. Building construction will continue for approximately fifteen months.

**Next Steps:** After the enrollee completes the remedial work, a RAR will be prepared and submitted to OER. The RAR will describe the cleanup activities and certify that all cleanup requirements were met. Once the RAR is approved, OER will issue a Notice of Completion, a City liability release, and a New York City Green Property Certificate. OER will then issue a fact sheet announcing the completion of the remedial action and identify all engineering and institutional controls to be used at the Site.
