The New York City Office of Environmental Remediation (OER) provides this Fact Sheet pursuant to New York City's Voluntary Cleanup Program (VCP). An application has been submitted by CNS Builders, LLC for enrollment of the property located at 116 Walton Street in the Williamsburg section of Brooklyn, New York and identified as Block 2250, Lot 25 into the VCP. The Remedial Investigation Report (RIR) details the results of an environmental investigation at the site including the nature and extent of contamination. The draft Remedial Action Work Plan (RAWP) proposes remedial actions to address contamination delineated in the RIR.

Public Comments on the RAWP

OER is accepting public comments on the draft RAWP for 30 days until January 26, 2014. The RIR and draft RAWP are available for review at the document repositories identified in the box on the left including a public library branch and through a link to OER's website. Comments should be sent to Mr. Shaminder Chawla via mail or e-mail (see contact information at left).

Site Description

The Site is 2,500 square feet and is currently vacant. The proposed future use of the Site consists of a 4-story apartment building with a full cellar and a cellar level rear yard.

Summary of RIR

The environmental investigation identified up to 2 feet of historic fill. Several Semi Volatile Organic Compounds (SVOCs), metals and pesticides were detected above cleanup guidelines.

Groundwater samples identified SVOCs and pesticides above Groundwater Quality Standards. Soil vapor samples showed petroleum-related and chlorinated VOCs at low concentrations, and below the monitoring level ranges established by New York State DOH.

Summary of the Remedy

The specific elements of the proposed remedial action include:

- Preparation of a Community Protection Statement and performance of all required NYC VCP citizen participation activities according to an approved Citizen Participation Plan;
- Performance of a Community Air Monitoring Program for particulates and volatile organic carbon compounds;
- Establishment of Track 1 Unrestricted Use Soil Cleanup Objectives (SCOs);
- Excavation and removal of soil/fill in excess of SCOs. The Site will be excavated to approximately 6 feet;
- Transportation and off-site disposal of all soil/fill material at permitted facilities in accordance with applicable laws and regulations for handling, transport and disposal of contaminated soil;
- Collection and analysis of end-point samples to determine if the remedy attains SCOs; and
- Submission of a RAR that describes the remedial activities, certifies that the remedial requirements have been achieved, lists any changes from this RAWP, and, if Track 1 SCOs are not achieved, describes all Engineering and Institutional Controls to be implemented at the Site.

If Track 1 Unrestricted Use SCOs are not achieved, the following Engineering Controls will be implemented as part of new construction:

- a. Installation of a vapor/waterproofing barrier system beneath the building slab and behind the foundation walls;
- b. Construction and maintenance of an engineered composite cover consisting of a building slab; and a minimum of two feet clean fill in the recreational outdoor area; and
- c. Submission of an approved Site Management Plan (SMP) in the RAR for long-term management of residual contamination, including plans for operation, maintenance, monitoring, inspection and certification of Engineering and Institutional Controls and reporting at a specified frequency.

Next Steps

OER will review the draft RAWP and consider all public comments submitted during the comment period before it approves a final RAWP. The approved RAWP will be placed in the public library branch and on OER's website and a second fact sheet will be issued before remedial work begins.

Figure 1 – Site Location Map




Figure 2 – Site Map
