**Note:** You will be required to pay a fee of twenty five (\$25.00) dollars if it has been sixty (60) days or more since your license was mailed.

**Note:** Should your TLC driver license or vehicle license be recovered, your failure to immediately return it to the Taxi and Limousine Commission may result in administrative and/or criminal penalties.

**TLC Drivers Only:** If you have an out of state license you must bring a **Certified Abstract (State Driver Record)** from the Department of Motor Vehicles and it must be stamped or sealed and cannot be older than ninety (90) days.
